Enlarged Partial Agreement on Sport (EPAS)

12th meeting of the Statutory Committee 10 July 2015, 10:00 – 12:00 Room of the Committee of Ministers Palais de l'Europe, Strasbourg

Decisions

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS), composed of the representatives to the Committee of Ministers of the member states of the Agreement¹, chaired by Ambassador Alexander Alekseev, Permanent Representative of the Russian Federation, held its 12th meeting in Strasbourg on 10 July 2015. The list of participants is featured in **Appendix I** of this document.

The Statutory Committee:

- I. Adopted the agenda as it appears in the **Appendix II** to this document;
- II. Approved the 2014 annual accounts of the Enlarged Partial Agreement for the period running until 31 December 2014 and consequently adopted Resolution EPAS/Res(2015)1 in relation to the financial statements of the Enlarged Partial Agreement on Sport (EPAS) for the financial year ending 31 December 2014, as it appears in **Appendix III** to this document;
- III. Noted the verbal report presented by the Secretariat concerning membership and observer requests by new countries, international sports federations and sport NGOs to the EPAS;
- IV. Noted the verbal report presented by Ms Wendela Kuper, Chair of the EPAS Governing Board, concerning the present priorities and future projects of the EPAS;
- V. Took note of the draft total of members' compulsory contributions to EPAS for 2016; took note of the draft 2016-2017 biennial programme as well as of the draft budget for the period to 31 December 2016 for this Enlarged Partial Agreement; took note of the 2017 draft budget and draft Resolution EPAS/Res(2015)2 as it appears in **Appendix IV** to this document.

Resolution EPAS(2015)1

concerning the budgetary management accounts of the Enlarged Partial Agreement on Sport (EPAS) for the year ended 31 December 2014

(Adopted by the Statutory Committee on 10 July 2015)

The Statutory Committee under the terms of Article 5.4 of the Statute of the Enlarged Partial Agreement and in its composition restricted to the Representatives of the States members in 2014 of the Enlarged Partial Agreement on Sport².

Having regard to Resolution CM/Res(2007)8 establishing the Enlarged Partial Agreement on Sport;

Having regard to Article 68 of the Financial Regulations;

Having regard to the budgetary management accounts of the Enlarged Partial Agreement on Sport of the year ended 31 December 2014, as presented by the Secretary General;

Having regard to the opinion of the External Auditor;

Having regard to the report of the External Auditor;

Having regard to the report of the Budget Committee,

Resolves as follows:

1. The financial statements of the Enlarged Partial Agreement on Sport for the year ended 31 December 2014 are approved (CM(2015)100 add, pages 117 to 124).

- 2. The unexpended appropriations for the financial year 2014 amounting to €17 795.27 as shown in the budgetary management accounts (CM(2015)100 add, page 124) presented by the Secretary General, are cancelled.
- 3. Approval is hereby given to the apportionment among the member States and non-member States of the €17 795.27 surplus, as indicated in the appendix to this resolution.
- 4. The share of the surplus of the Enlarged Partial Agreement on Sport budget due to each state will be applied to meet any additional contributions for which states may become liable should supplementary appropriations be granted in the 2015 budget, any part of the share that remains being considered as an advance on its contributions for 2016.
- 5. The budgetary management accounts with the present resolution, as well as the report of the External Auditor, will be transmitted to the Committee of Ministers.

Draft Resolution EPAS-Res(2013)2 concerning the Enlarged Partial Agreement on Sport 2016-2017 Budgets

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS)³, composed of the representatives on the Committee of Ministers of the member states of the agreement.

Having regard to Resolution CM/Res(2007)8 of 11 May 2007 authorising the establishment of the Enlarged Partial Agreement on Sport;

Having regard to Articles 19, 21 et 28 of the Financial Regulations;

Having noted the changes in the EPAS membership for 2016, compared to 2015;

Having regard to the Programme and Budget for 2016-2017 (CM(2015)130);

Resolves as follows:

1. The biennial programme 2016-2017 as it appears in document CM(2015)130 is hereby approved.

- 2. The budget of expenditure and the budget of receipts for 2016, totalling €777 900 according to Table A appended hereto are hereby approved.
- 3. The budget of expenditure and the budget of receipts for 2017, totalling €777 900 according to Table A appended hereto are hereby approved on a provisional basis.
- 4. Approval is hereby given to the apportionment, among the states which are members of the Enlarged Partial Agreement on Sport of the contributions for 2016 totalling €777 900 according to Table B appended hereto.
- 5. The total of the budget of receipts shall be a function of actual receipts. The budget of expenditure and receipts will be adjusted accordingly in the course of the financial year.
