**Dear Madam,**

Please let me, first of all, assure you of our outmost respect.

As regards general measures taken for implementation of the Court's judgments in the case of "*Burmych and others v. Ukraine*" and group of cases "*Yuriy Nikolayevich Ivanov/Zhovner*" the Government would like to submit the following information.

At their 1302<sup>nd</sup> meeting (December 2017) (DH), the Committee decided to invite the Government regularly to inform the Committee of the progress achieved in setting up the *ad hoc* redress mechanism for all applicants concerned by the *Burmych and others* judgment, for the purpose to secure a long-lasting solution addressing the root cause of the problems that was found by the Court in abovementioned group of cases. Thereby the Committee requested the Government to submit by 15 February 2018 respective action plan.

Please be informed that the preparation of the action plan with a concrete roadmap and clear time-table in the above group of cases requires collection of the additional information from various domestic authorities. Alas, so far only a part of the relevant information sought from the authorities has been provided and this partial information does not allow the Government to supply the Committee with action plan for solving problematic issues required under mentioned group of cases.

For these reasons the Government respectfully request the Committee to extend the time-limit for submission of the Government's action plan.
