LETTER OF COMPLAINT

OBJECT: Complaint against non-executing of decisions of European Court of Human Rights and irregularities of Albanian State Advocate Alma Hicka.

Dear and honored Gentlemen,

My name is Selami Kreka resding at address mentioned above.

I would like to thank you for acceptable response sent on January 16, 2018 with reference to Application Nr. 33151/11/ and irrevocable decision with three months term by European Court of Human Rights. Albanian Government through Ministers' Council Resolution Nr. 615 of date August 28, 2016 has committed for execution of decision of European Court of Human Rights. The Albanian Government hasn't necessary seriousness, drags out and cheats. There were about 24 months, years 2016, 2017, 2018 without executions of these decisions; Prime Minister Cabinet, ministers and others high officials has claimed from ATP (Agency of Property Treatment) to compensate these decisions; ATP (Agency of Property Treatment) refuse and justify with pretention that it hasn't funds. In December of the year 2017, Ministers' Council in official gazette notified that the execution will be performed by State Budget.

The government though official website notifies that 43 owners and heirs will take their money of compensation. A. 21 owners with name Karagjozi etc. will get: 5.319.000 Euro. B. 9 owners in the list Halimi etc will get 1.154.300 Euror. C. 13 owners of list Alicko will get 5.185.000 Euro. Based on this notification I addressed to Minister of Justice Mrs. Etilda Gjonaj a petition for compensation attaching legal documents; ID card, and my account nr., issued by Credins Bank where the money will be deposited. But, what happened?! On the side of Ministry of Justice, the state advocate, Mrs. Alma Hicka ignores decision of European Court of Human Rights. She confuses petition with complaint. She sends an abusive strange and incorrect letter. Alma says: I have in my disposal a complaint letter of yours with reference to non-restitution of your property by KKKP (Commission of Restitution and Compensation of Property), Korce by judicial organ or local governmental officials who have denied property restitution; Second: From your complaint doesn't result what you are seeking because you haven't a property decision, court order with number and date; Third: Remonstrant has to make another more

detailed complaint presenting documents or to be appeared himself. As above I explain: I responded her making known to Prime Minister and Ministry of Justice. I haven't complained against KKKP (Commission of Restitution and Compensation of Property), Korce. This organ has been correct; it has issued a correct certificate of ownership; the European Court of Human Rights in Strasbourg has given a right decision too. The advocate herself has been representative in Court of Strasbourg. How I didn't know what I am looking for? To whom I am complaining? Why she look for another complaint? What is the value of it? Citizen's property isn't property of corrupted and governmental officials. It is holly and untouchable. I am attaching in Albanian Language advocate's original letter.
