



Communication on behalf of the applicant in the case of Kudeshkina v Russia

(Application no. 29492/05)

Following the letter dated 29 January 2018, the applicant brings to the attention of the Committee of Ministers further developments of the implementation of the case of Kudeshkina v Russia.

At the end of January 2018 the applicant's representative, Ms. Moskalenko, received the responses of the RF Ministry of Justice and the Qualification Penal of Judges of the City of Moscow on account of the applicant's letters dated 15 December 2017.

The Qualification Penal of Judges of the City of Moscow informed the applicant that it was not authorized to communicate with the applicant to negotiate the possible ways of implementation of the referred judgment. (Attachment 1)

The Ministry of Justice, in its turn, informed the applicant that the content of the applicant's letter dated 15 December 2017 was taken into account. (Attachment 2)

On 2 March 2018 the applicant sent the Ministry of Justice her suggestions regarding the execution of this judgment as requested by the letter of 22 February 2018 addressed to the Department for the Execution of Judgments of the European Court of Human rights (Attachment 3)
