Please let me, first of all, assure you of our outmost respect.

As regards individual measures taken for implementation of the Court's judgments in the group of *Oleksandr Volkov/Salov* cases (applications nos. 21722/11 and 65518/01) the Government of Ukraine would like to submit the following information.

# Just satisfaction

As to the payment of just satisfaction in the case of *Kulykov and others v. Ukraine* (application no. 5114/09) the Government of Ukraine would like to notice that due to failure of the applicants, Lyudmyla Ivanivna Stasovska (application no. 20554/11) and Aleksandr Ivanovich Volvenko (application no. 77810/12), to submit their full banking details, the just satisfaction sums, awarded by the Court, have been transferred to the special deposit account of the Ministry of Justice of Ukraine on 08 and 14 June 2017, respectively (*the payment orders are enclosed thereto*). Thus, the amounts are available to the applicants upon submission of full banking details.

#### Restitutio in integrum

The applicant in the case of *Feldman* (application no. 76556/01) did not avail himself of the possibility provided by domestic legislation to apply for review of the impugned proceedings.

As regards the case of *Salov* (application no. 65518/01), on 26/01/2007 the Supreme Court quashed the domestic courts' decisions criticised by the Court and terminated the criminal proceedings due to the absence of *corpus delicti*.

As regards the case of *Belukha* (application no. 33949/02), upon request of the applicant, on 22 May 2008 the Supreme Court of Ukraine quashed the domestic courts' decisions criticised by the Court and remitted the case for a fresh consideration to the Kramatorsk Town Court of Donetsk Region.
