As to the execution of the Court's judgment in the case of Shyshkov. v. Ukraine

Dear Sir,

Please let me, first of all, assure you of our outmost respect.

As regards the case of Shyshkov. v. Ukraine (application No. 18073/15) and in order to provide information concerning the applicant's current situation the Government of Ukraine would like to submit the following information.

On 17 December 2013 the applicant received a copy of indictment in criminal proceedings regarding an alleged criminal offence envisaged by Articles 307.2, 310.2 and 311.2 of the Criminal Code of Ukraine that had been entered in the Unified Register of Pre-Trial Investigations as per No. 42013180000000017.

Within four years and two months the Poltavskyi District Court in Poltava Region kept extending the applicant's detention on remand and on 11 April 2017 it ruled to change a preventive measure from detention on remand to house arrest until 9 June 2017. Thus, the applicant was released immediately in the court room.

On 29 May 2017 the Poltavskyi District Court in Poltava Region sentenced the applicant to eight years and four months imprisonment without confiscation of property. However, according to Article 72.5 of the Criminal Code of Ukraine, the court found that the applicant had already discharged the term of sentence and released him from punishment. Also, the preventive measure in form of the house arrest was repealed.

Therefore, the applicant, Shyshkov Sergiy Anatoliyovych, has been released from pre-trial detention and the criminal proceedings in his case have been concluded.
