Please let me, first of all, assure you of our outmost respect.

As regards action plans on individual and general measures taken for implementation of the Court's judgments in the group of cases "Merit/Naumenko v. Ukraine", "Lutsenko/Tymoshenko v. Ukraine" and case of "Lutsenko (No. 2) v. Ukraine" (application No. 29334/11) the Government would like to submit the following information.

Please be informed that the preparation of the action plans in above cases requires collection of the additional information from various domestic authorities. Alas, so far only a part of the relevant information sought from the authorities has been provided and this partial information does not allow the Government of Ukraine to supply the Committee with comprehensive action plans.

For these reasons the Government of Ukraine respectfully request the Committee to extend the time-limit for submission of the Government's action plans in the above-mentioned cases and groups of cases until the end of June 2018.
