8th Meeting of the Statutory Committee Strasbourg, 21 October 2011 10h00-12h00 Room of the Committee of Ministers, Strasbourg

Final Decisions

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS), composed of the representatives on the Committee of Ministers of the member states of the Agreement¹, chaired by Ambassador Alexander Alekseev, Permanent Representative of the Russian Federation, held its fifth meeting in Strasbourg on 21 October 2011. The list of participants is featured in **Appendix I** of this document.

The Statutory Committee:

- I. Adopted the agenda as it appears in the **Appendix II** to this document;
- II. Approved the annual accounts for 2010 of the Enlarged Partial Agreement for the period running until 31 December 2010; and consequently adopted Resolution EPAS-Res(2011)1 in relation to the financial statements of the Enlarged Partial Agreement on Sport (EPAS) for the financial year ending 31 December 2010; as it appears in **Appendix III** to this document;
- III. Noted the verbal report presented by the Secretariat concerning membership and observer requests by new countries, international sports federations and sports NGOs to the EPAS;
- IV. Noted the verbal report presented by the Secretariat concerning the present priorities and future projects of the EPAS;
- V. Approved the programme of activities as it appears in **Appendix IV**. Determined the total of members' compulsory contributions to the EPAS; noted that an updated the scale of contributions² of participating states (Table B) will be circulated with views it adoption by written procedure; approved the budget for the period to 31 December 2012 for this Enlarged Partial Agreement, and

- consequently adopted Resolution EPAS-Res(2011)2 as it appears in **Appendix V** to this document, provided the update of the Table B is approved ³;
- VI. Took note of the requests for observer status from organisations selected by the EPAS Governing Board (see document EPAS (2011) 6rev4 and invited the Ministers' Deputies, in their composition restricted to the representatives of the member States of the EPAS, to adopt the Draft Decision as it appears in document EPAS-SC (2011) 5 (**Appendix VI** to this document), to allow the EPAS Governing Board to grant observer status to these organisations and to incorporate these organisations into its Consultative Committee, without further debate, at its 1126th meeting (16 November 2011).
- VII. Took note of the invitation from the Serbian Minister to host the 12th Council of Europe Conference of Ministers responsible for sport in Belgrade, on 15 March 2012, and noted the elements regarding the Conference presented in document EPAS-SC (2011) 6; consequently invited the Secretariat to include this event in the Calendar of Ministerial Conferences in the section "Conferences organised by Partial Agreements", according to the EPAS Statute and to Resolution CM/Rec(2011) 7⁴.
- VIII. Agreed that the date of the next meeting of the Statutory Committee will take place in October 2012 and will be confirmed later by the Secretariat.

The Statutory Committee. under the terms of Article 5.4 of the Statute of the Enlarged Partial Agreement. and in its composition restricted to the Representatives of the States members in 2010 of the Enlarged Partial Agreement on Sport.¹

Having regard to Resolution CM/Res(2007)8 establishing the Enlarged Partial Agreement on Sport;

Having regard to Article 70 of the Financial Regulations;

Having regard to the budgetary management accounts of the Enlarged Partial Agreement on Sport for the year ended 31 December 2010, as presented by the Secretary General;

Having regard to the opinion of the External Auditor;

Having regard to the report of the External Auditor;

Resolves as follows:

1. The financial statements of the Enlarged Partial Agreement on Sport for the year ended 31 December 2010 are approved (CM(2011)100 add, pages 159 - 166);

- 2. The unexpended appropriations for the financial year 2010 amounting to €46 045.23 as shown in the budgetary management accounts (CM(2011)100 add, page 166) presented by the Secretary General, are cancelled;
- 3. Approval is hereby given to the apportionment among the member states of the €46 045.23 surplus; according to the scale of contributions adopted for the financial year 2010.
- 4. The share of the surplus of the Enlarged Partial Agreement on Sport budget due to each state will be applied to meet any additional contributions for which states may become liable should supplementary appropriations be granted in the 2011 budget, any part of the share that remains being considered as an advance on its contributions for 2012.
- 5. The budgetary management accounts with the present resolution, as well as the report of the External Auditor, will be transmitted to the Committee of Ministers.

Enlarged Partial Agreement

Created in 2007

The Enlarged Partial Agreement on Sport (EPAS) was established in 2007, in order to give fresh momentum to pan-European sports co-operation and address the current challenges facing sport in Europe – building on more than 30 years of activity in the field.

EPAS provides a platform for intergovernmental sports co-operation between the public authorities of member states of the agreement. EPAS also encourages dialogue between public authorities, sports federations and NGOs. This contributes to better governance, with the aim of making sport healthlier and fairer, and ensuring that it conforms to high ethical standards.

EPAS aims to promote the development of sport in modern society, while emphasising its positive values. It develops policies and standards, monitors them and helps with capacity building and the exchange of good practice. It

uses Council of Europe sports standards such as the European Sports Charter, the Code of Sports Ethics, the European Convention on Spectator Violence and the Anti-Doping Convention as the basis for drawing up its own strategies. Its activities are developed in line with political priorities expressed at ministerial meetings.



Resolves as follows:

- 1. The biennial programme 2012-2013 as it appears in document CM(2011)130 addendum revised pages 5 to 7 is hereby approved.
- 2. The budget of expenditure and the budget of receipts for 2012, totaling €846 300 according to Table A appended hereto are hereby approved.
- 3. The budget of expenditure and the budget of receipts for 2013, totaling €846 300 according to Table A appended hereto are hereby approved on a provisional basis.
- 4. Approval is hereby given to the apportionment, among the states which are members of the Enlarged Partial Agreement on Sport of the contributions for 2012 totaling €846 300 according to Table B appended hereto.
- 5. The total of the budget of receipts shall be a function of actual receipts. The budget of expenditure and receipts will be adjusted accordingly in the course of the financial year.
