Foreword

At their 643rd meeting (6-7 October 1998, Item 3.1) the Ministers' Deputies examined Parliamentary Assembly Recommendation 1382 (1998) on Drawing up of a European Code of Conduct on arms sales and discussed on possible follow up. They decided to bring this Recommendation to the attention of their Governments and instructed the Rapporteur Group on Legal Co-operation (GR-J) to examine it with a view to preparing a draft reply to the Assembly.

The GR-J examined the Recommendation at its meeting on 7 December 1998. It held an initial exchange of views on the Assembly's proposals, which is detailed in the synopsis of the meeting (see GR-J (99)1). The group agreed to hold a second exchange of views on the basis of additional documents - to be supplied by the Secretariat - relating to international texts already adopted.

At its meeting on 11 February 1999, the Group held a second exchange of views. A consensus was reached on the idea of assigning ad hoc terms of reference to the Ad Hoc Committee of Legal Advisers on Public International Law (CAHDI), instructing it to prepare an opinion on the Recommendation (see GR-J (99) 7).

Thus, at the GR-J's proposal, at their 661st meeting at A level (Strasbourg, 24-25 February 1999) the Ministers' Deputies assigned ad hoc terms of reference to CAHDI, instructing it to give an opinion on Parliamentary Assembly Recommendation 1382 (1998) concerning its follow up.
