NEW CAHDI INTERNET SITE

The Council of Europe Secretariat General has set up a new internet site for up to date information about Council of Europe's work in the field of public international law including the CAHDI, its structure, functioning and operation, activities, adopted texts, etc.

CAHDI delegates will be able to access unrestricted CAHDI working documents and download and print them using the Acrobat Reader Software (further details in the site – *Working documents*). The site is in English and French.

The structure of the site is as follows:

 - o List of meetings (including the agenda, a summary of the items discussed and decisions taken and the meeting report)

 - o Working documents (unrestricted CAHDI working documents)
