- Ad hoc mandate to study the Venice Commission's report on Private Military and Security Firms and Erosion of the State Monopoly on the use of force CAHDI (2010) 15, 16 prov & 26; CDL-AD (2009) 038

On 21 April 2010, the Ministers' Deputies adopted Decision No. CM/881/21042010, giving ad hoc terms of reference to the Committee of Legal Advisers on Public International Law (CAHDI), to study the suggestions made in the Venice Commission's report on Private Military and Security Firms and Erosion of the State Monopoly on the Use of Force, in the light of the Parliamentary Assembly Recommendation 1858 (2009) on the same subject, and to report back.

The ad hoc terms of reference given to the CAHDI, expiring on 31<sup>st</sup> December 2010, as well as the Venice Commission's report on Private Military and Security Firms and Erosion of the State Monopoly on the Use of Force are set out respectively in documents CAHDI (2010) 15 and CDL-AD (2009) 038. The draft opinion of the Committee, which was prepared by the Secretariat and approved by the Chair and the Vice-Chair of the Committee, is set out in document CAHDI (2010) 16 prov.

The contribution of Switzerland appears in document CAHDI (2010) 26.

- Request for possible comments of the CAHDI on Recommendation 1913 (2010) – "The necessity to take additional international legal steps to deal with sea piracy" CAHDI (2010) 17 prov
