In view of the development of the PC-OC website, the Secretariat invited delegations to propose links to websites of relevance to the work of the PC-OC and of practitioners active in the field of international co-operation in criminal matters. The suggested links were discussed during the 61<sup>st</sup> meeting of the PC-OC.

The PC-OC concluded that it would be useful to compile links to websites of relevant intergovernmental organisations and international courts as well to relevant governmental websites.
