[Updates on Financial Reports to be submitted to EYF]



[Make sure you read the guideline docs before you start your report!]

To help you present a full report and get the outstanding 20% of the grant as quickly as possible after the end of your activity, we developed templates and guideline documents. (See: Resources/Guidelines and Templates)

The "Guidelines for financial reporting for Pilot Activities, International Activities and Work Plans" document has been recently updated.

- -All reports received as from 1 September 2014 must follow the guidelines if not, the report will be sent back.
- -Salaries are not accepted unless paid by another proven source of funding. While avoiding the professionalization of the youth sector and in agreement with the EYF spirit, no salaries will be covered by EYF grants. MORE...

[Last pilot activity deadline of the year 2014]



[12 DAYS left if you wish to send your application for this year!]

Unlike the other grant types, applications for pilot activities do not have a specific deadline. Pilot activity applications must however be submitted at least three months before the beginning of the activity. The decisions on application are then usually taken by the Programming Committee on Youth every 4-6 weeks.

The last batch of applications for pilot activities starting before the end of 2014 will be given to the Programming Committee at the beginning of October. This means that applications must be received before the 15th of September. Applications received after the 15th of September should concern projects starting in 2015. MORE...
