Mr Alfonso de Salas, Secretary of the Steering Committee on Human Rights (CDDH) will inform the Committee about of the new Terms of Reference of the DH-MIN adopted by the Ministers' Deputies on 11-12 February 2009 and their particular implications for the work of the Committee

Item 3: Presentation of the expert study of the replies to the questionnaire on the ethnic data collection, discussion and consideration of future work to be carried out on this theme

At its seventh meeting in March 2008, the Committee continued its discussion on the theme of permissibility of ethnic data collection and appropriate methods for gathering such data. It requested that an expert analysis of the responses to the questionnaire on ethnic data collection be elaborated with a view to discussing it at a future meeting.

Mr Patrick Simon, researcher at the *Institut national d'études démographiques* (INED) will present his analysis of the responses to the questionnaire in question.

Following this presentation, the Committee will exchange views on the possible future work on this theme, and will take a decision on the possible publication of this report.

Examination of the final text of the report prepared by Mr David Hine, Director, Centre for the Study of Democratic Government in Oxford on the "Electoral systems, party law and the protection of national minorities" (doc.ref.: DH-MIN(2006)013 prov3; English version only) with the view to its publication

At its seventh meeting in March 2008, the Committee continued its discussion on the theme of electoral laws and the laws on political parties that are relevant for national minorities. In the light of this discussion and the additional contributions which followed, Professor David Hine, Director of the Centre for the Study of Democratic Government in Oxford updated his report. This report was sent out to the Members in February 2009.

Member States are invited to take a decision on the possible publication of this updated report.

Item 5:

Expert presentations of the promotion of the use of languages of persons belonging to national minorities in minority communities on behalf of Croatia, Moldova and Hungary

At its last three meetings, the Committee heard testimonies on good practices in the field of the promotion of use of native languages in minority communities in the Slovak Republic, Romania, Serbia, Switzerland and Italy and on the "Position of France on the use of languages of origin and mother tongues in the field of education".

The Committee decided to continue to examine this topic and to invite other States, to introduce their case-studies of good practices in this field at the forthcoming meetings.

Ms Mr Furio Radin, President of the Parliamentary Committee for Human and Minority Rights in the Sabor (Parliament) of Croatia will make a presentation on the measures applied to protect the rights of the Italian minority in Croatia.

Ms Ewa Słaba-Rónay, Director of the Polish School in Budapest will inform the Committee about the education system for lesser-used languages in Hungary on the example of the Polish education facilities in Hungary.

Ms Ala Nikitcenko, expert at the Ministry of Education and Youth in Chisinau, Moldova will speak about measures taken to protect the rights of the national minorities in the education sphere in the Republic of Moldova.

Following these presentations, the Committee will exchange views on the possible future work on this theme.
