# 5. BOSNIA AND HERZEGOVINA

The Advisory Committee notes that the Constitutional Court in its partial decision No. 5/98 of 30 June and 1 July 2000 published in the Official Gazette of 14 September 2000, declared unconstitutional, *inter alia*, paragraph 5 of the Preamble of the Constitution of the Republika Srpska, which recognised "the natural and democratic right, will and determination of the Serb people from the Republika Srpska to link its State completely and tightly with other States of the Serb people". The Advisory Committee welcomes the new wording of the Preamble of the Constitution of the Republika Srpska, which now, *inter alia*, expresses the intention "to contribute to the development of friendly relations among the peoples and States", a wording that appears fully in the spirit of Article 2 of the Framework Convention.
