



Crises management and governance: Luxembourg's approach





Findings

- **inclusion of persons with disabilities in crisis management remains very insufficient;**
- **lack between principles defined in Article 11 of the UN Convention on the Rights of Persons with Disabilities and the implementation programs for adequate protection of persons with disabilities;**
- **lack of harmonisation and concerted action among state services;**
- **tendency to divide responsibilities between different ministries and state agencies;**
- **lack of communication.**



Challenge

- including persons with disabilities in crises management should involve political authorities, public administrators, civil protection authorities and civil society organisations;
- no common and coordinated approach in crises management;
- lack of central coordinated strategic planning;
- lack of common communication strategy;
- integrated approach ensuring inclusion of persons with disabilities in disaster management is lacking.



Luxembourg concept

- new national protection concept;
- implementation of an overall concept of crises prevention and management called "all sectors - all risks";
- aim: setting up structures and mechanisms for better coordination between public actors in crisis management.



New approach

- **High Commission of National Protection (HCPN) responsible for inter-ministerial coordination of all actors involved in crisis management, without interfering in the responsibilities of the different state actors;**
- **Superior Council for National Protection (CSPN): a common platform with all actors involved in disaster management;**
- **common platform for preparation, planning and crisis management;**
- **harmonized approach to all crises, including the harmonization of response plans, organization of response, operational management and communication.**



Harmonized crises response

- **Crisis Cell (CC) is composed of members of CSPN (police, emergency services...);**
- **Ministry of Family, authority responsible for persons with disabilities, is ex officio member of CC;**
- **facilitates the inclusion of the needs of people with disabilities in crisis management.**



Emergency planning

- harmonization of emergency and response planning;
- same structure of all plans;
- general response plan defines the alert procedures, responsibilities of the actors, preventive and protection measures;
- operational plans attached to the general plan describe specific measures;
- specific needs of persons with disabilities are included in operational plans.



Nuclear emergency planning: 18 operational plans

1. Radiological evaluation, zoning
2. Individual protection measures
3. Distribution of potassium iodide tablets
4. Sheltering of the population
5. Organization and control of access to affected areas
- 6. Evacuation of the affected population**
- 7. Management of rest centers**
- 8. Decontamination of persons**
9. Control, protection and use of food
10. Control and protection of agricultural products and livestock
11. Internal Communication
12. External Communication
13. International cooperation: mutual assistance
14. Hospital facilities
- 15. Homes for elderly/ disabled persons**
16. Schools
17. Transportation Management
18. Water management
