 - for funding under the ISEC programme to develop new further training courses including intermediate ones.
 - for funding under the ISEC programme to further develop the 2CENTRE project introducing further national centres into the network
 - update a selection of the currently available training courses.
- Accept Interpol's offer to fund the upgrade and restructure of the existing introductory course on forensic computing and network investigations
