Global

 All over the world, ICT companies face pressure from governments to follow laws and policies that conflict with internationally recognized human rights of freedom of expression and privacy.

Network

- A multi-stakeholder group of companies, human rights groups, press freedom groups, academics and investors responding with a collaborative approach to protect freedom of expression and privacy
- Aim to become the global standard

- Launched in October 2008, the 60th Anniversary year of the Universal Declaration of Human Rights and based in internationally recognized standards:

Findings to Date

- Large sections of Principles and Implementation Guidelines are relevant (top level commitments; due diligence; responsible decision making; collaboration)
- Need to further address: Product Functionality; Due Diligence/Use Phase;
 Consulting; Government Mandates/Demands.
