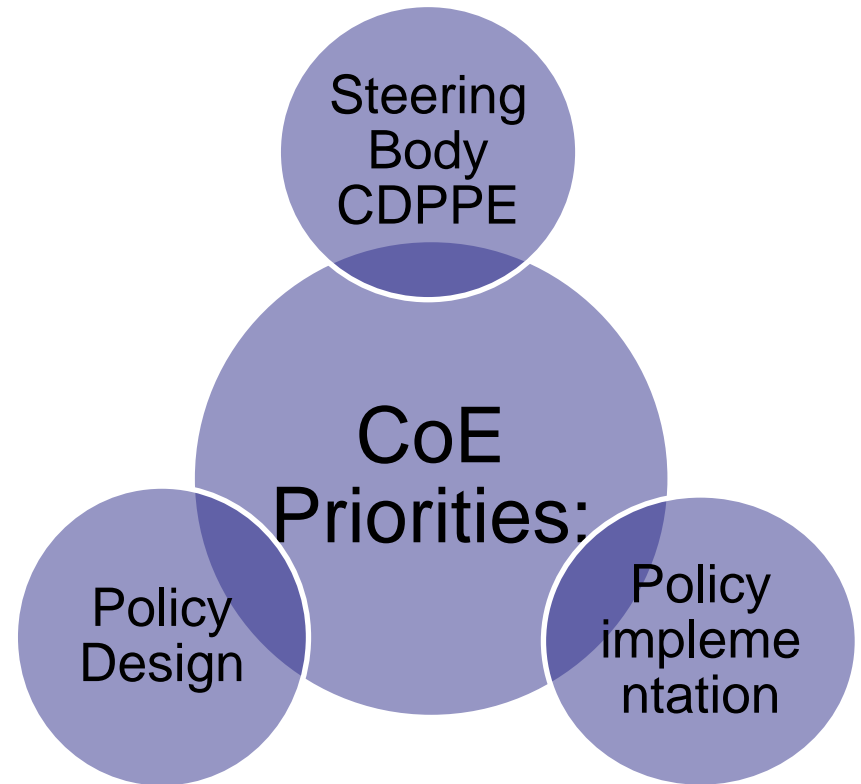

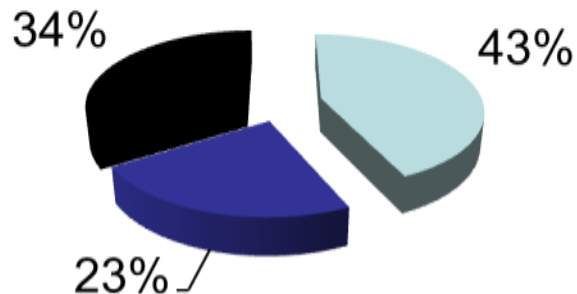

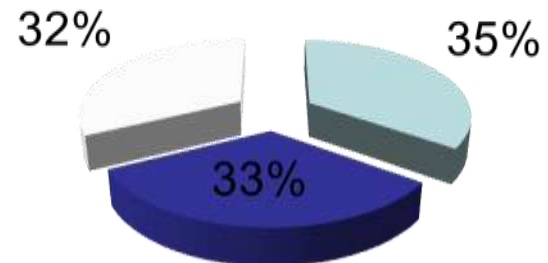

# **Citizenship and Human Rights Education: latest developments since Baku meeting**

- EU/CoE Pilot Projects Scheme: two projects under way
- International Contact Group: Meeting on 7-8 October in Paris
- Publication on Curriculum Reform: Revised draft
- 2<sup>nd</sup> Review cycle



## Competences for Democracy and Intercultural Dialogue

- Develop a framework of descriptors of competences for a culture of democracy and intercultural dialogue.
- *Non-binding*: guidance to member states which they can use and adapt.



## **Higher education for democratic culture**

- Cooperation with the US Steering Committee of the International Consortium for Higher Education, Civic Responsibility, and Democracy
- Cooperation with the European Wergeland Centre and other partners



# Strengthening Cooperation and Fostering Synergies

- Facilitating cooperation and support among the countries
  - Monitoring mechanisms including the ECHR
- Intersectorial cooperation: Gender, LGBT,
- Ensuring the involvement of key partners
- Bridging policy and practice
- Promoting synergies with other institutions
