4th MEETING Strasbourg, 26-28 November 2013

ABRIDGED REPORT

Adoption of the agenda

 The Committee on Bioethics (DH-BIO) held its 4th meeting in Strasbourg from 26 to 28 November 2013. The agenda of the meeting and the list of participants appear in Appendix I and Appendix II to this abridged report.

Chart of signatures and ratifications of the Convention on Human Rights and Biomedicine, the Protocol on the Prohibition of Cloning Human Beings, the Protocol concerning Transplantation of Organs and Tissues of Human Origin, the Protocol concerning Biomedical Research and the Protocol concerning Genetic Testing for Health Purposes

2. The DH-BIO was informed that on 7 August 2013, Moldova ratified the Additional Protocol to the Convention on Human Rights and Biomedicine, regarding Biomedical Research.

Developments in the field of bioethics

 The DH-BIO took note of the developments in the field of bioethics within the member states, as well as in international organisations. It was also informed of the relevant developments in other Council of Europe bodies.

Decision-making process regarding medical treatment in end-of-life situations

- 4. The DH-BIO examined the draft Guide revised by the Drafting Group in the light of the comments received in the framework of the public consultation organised from February to April 2013.
- 5. Following one modification to a paragraph concerning the principle of autonomy, and subject to editorial and linguistic revision, the DH-BIO approved the Guide on the decision-making process regarding medical treatment in end-of-life situations.
- 6. The DH-BIO agreed:
 - to send the Guide as approved to the Steering Committee for Human Rights (CDDH);
 - to invite the CDDH to take note of the Guide and to submit it to the Committee of Ministers for taking note.
- 7. The DH-BIO agreed to launch the Guide at a Conference to be organised under the Austrian Chairmanship of the Committee of Ministers on 5 May 2014.

Predictivity, genetic testing and insurance

- 8. The DH-BIO examined a preliminary draft text for a possible legal instrument prepared by the Secretariat in consultation with experts having participated in the previous Working Group, which had been revised in the light of comments made by delegations.
- 9. Following this examination and in response to the terms of reference given by the Committee of Ministers¹, the DH-BIO agreed:
 - to prepare a non-legally binding instrument in the form of a Recommendation on the use for insurance purposes of personal health-related information, in particular information of a genetic and predictive nature;
 - to make public the preliminary draft Recommendation prepared by the Secretariat in consultation with experts having participated in the previous Working Group, in order to

Expected results for 2013:

"(ii) b. a feasibility study is conducted and, if appropriate, a draft legal instrument prepared on the use of predictive health related data for insurance purposes;"

- facilitate consultation of the text by delegations at national and international level, after having introduced a few changes, in particular in the Preamble and the Purpose.
- Delegations were invited, after having carried out their consultation, to send their comments on the preliminary draft Recommendation <u>no later than 30 March 2014</u>, with a view to their discussion at the 5th plenary meeting (5-7 May 2014).
- 11. The DH-BIO also agreed to invite, in this context, the Consultative Committee of the Convention for the Protection of Individuals with regard to Automatic Processing of Personal Data (T-PD), to comment on the preliminary draft Recommendation.

Genetic testing for health purposes: information document on genetic testing, in particular its nature and possible implications of its results

- 12. The DH-BIO was informed that the information document on genetic testing had now been translated into 27 non-official languages thanks mainly to the help and support of the European Society of Human Genetics (ESHG) and EuroGentest.
- 13. Delegations were invited to:
 - indicate the names of organisations/institutions to which the information document could be sent directly for dissemination:
 - send information on the dissemination and use of this information document at national level.

Re-examination of Recommendation (2006) 4 on research on biological materials of human origin

- 14. At its last plenary meeting, the DH-BIO agreed to consult the Consultative Committee of the Convention for the Protection of Individuals with regard to Automatic Processing of Personal Data (T-PD) on the issues identified by the Drafting Group, in particular those relating to the concepts of identifiable or non-identifiable biological materials, and transborder flows. The Secretary of the T-PD presented the opinion prepared in response to this request. The DH-BIO thanked the T-PD for the elements of answers provided.
- 15. The DH-BIO examined the revised draft Recommendation prepared by the Drafting Group in the light of the comments made by delegations. It discussed in particular the articles concerning the removal of biological materials, from persons not able to consent, for storage for future research and concerning storage for future research of residual biological materials.
- 16. The DH-BIO agreed, in principle, to keep the provisions concerning the removal of biological materials, from persons not able to consent, for storage for future research. The formulation of these provisions may, however, be revised.
- 17. With regard to residual biological materials, the DH-BIO agreed to keep in the text the reference to the provisions concerning prior information foreseen in the case of removal for storage for future research.
- 18. The DH-BIO entrusted the Drafting Group with preparing, and subsequently submitting to the Bureau, a revised version of the draft Recommendation based on the following instructions:
 - review all provisions in order to, where necessary, insert a reference to associated data;
 - review the relevant provisions in order to address the case where biological materials have been anonymised.
- 19. The DH-BIO agreed, subject to approval by the Bureau, to make public for consultation the draft Recommendation, revised in this way, as a working document.
- 20. The DH-BIO entrusted the Secretariat with sending this text to experts/organisations/institutions that had been invited to attend the symposium organised in June 2012 and to invite them to send their comments on the text no later than 15 August 2014.

21. The DH-BIO entrusted the Drafting Group to prepare after this a revised version of the text in the light of the comments which will be received during the consultation.

Additional Protocol on the protection of the dignity and fundamental rights of persons with mental disorders with regard to involuntary treatment and involuntary placement

- 22. The Committee considered the question of the scope of the future additional protocol, with the participation of all the members of the Drafting Group entrusted with the preparation of this protocol.
- 23. It was agreed to keep the scope originally foreseen by the Steering Committee on Bioethics (CDBI), excluding "measures taken in relation to criminal offences".
- 24. Regarding the applicability of the future protocol to persons subjected to an involuntary measure on the ground of a mental disorder while serving a prison sentence or in detention, but without any link between the measure and a criminal offence (whether the offence at the origin of the prison sentence or detention or a different one), it agreed to ask the opinion of the European Committee on Crime Problems (CDPC), when work on the preparation of the protocol has progressed further.
- 25. The DH-BIO supported the proposal made by the Drafting Group to organise a hearing with the INGOs representing the different sectors concerned. This hearing would be held on 10 or 11 March 2014 (date to be confirmed), during a meeting of the Bureau and would be co-chaired by the Chairperson of the DH-BIO and the Chair of the Drafting Group.
- 26. Delegations that have not yet done so were invited to send their comments on the issues raised by the Drafting Group no later than 10 December 2013 so as to allow the Group to examine them at its meeting to be held on 12-13 December 2013.
- 27. In the light of the comments received from the delegations and the remarks which will be made at the hearing, the Drafting Group would prepare a preliminary draft Protocol to be submitted to the DH -BIO at its 5th meeting (5-7 May 2014).
- 28. The DH-BIO agreed to submit in due course the text of this draft for comments to the Office of the High Commissioner for Human Rights of the United Nations (OHCHR).

Prenatal sex selection

- 29. The DH-BIO considered the proposals for action(s) made by the delegations to address the issue of prenatal sex selection.
- 30. The DH-BIO agreed to entrust the Bureau with the task of reflecting further on this question, in the light of the proposal presented by the Secretariat on the basis of the suggestions sent by delegations, and taking into account the cultural dimension of the issue.

Cooperation programme (DEBRA)

31. The Secretariat informed the DH-BIO that, at the request of the Slovak Delegation, a conference would be organised in Bratislava, at the end of May 2014, on genetic testing for health purposes in Central and Eastern Europe. The aim of this conference would be to contribute to promoting the principles laid down in the Additional Protocol to the Convention on Human Rights and Biomedicine, concerning Genetic Testing for Health Purposes.

Election of the Chair and the Vice-Chair

32. By acclamation and for a new term of office of one year, the DH-BIO re-elected as its Chairperson Dr Anne Forus (Norway) and, as its Vice-Chair, Dr Mark Bale (United Kingdom).

Future activities and working methods of the DH-BIO

Expert study on emerging technologies

- 33. The draft study on scientific developments in the field of emerging technologies was presented to the DH-BIO by the Rathenau Institute (NL) which had been commissioned to prepare it. The study would be finalised at the end of December 2013 and then made public.
- 34. The DH-BIO agreed to entrust the Bureau with the task of selecting the drafter(s) of the second study on emerging technologies which would focus on ethical questions raised by these technologies. The selection would be based on suggestions to be sent by delegations no later than 10 January 2014.

2014-2015 biennium

35. The DH-BIO was informed of the adoption by the Committee of Ministers of its terms of reference for the period 2014-2015. These include all the activity proposals made by the DH-BIO for this next biennium.

Trafficking in human organs

36. The Committee was informed that the Parliamentary Assembly had adopted an Opinion on the draft Convention against Trafficking in Human Organs, which had been transmitted to the Committee of Ministers. The draft Convention would be examined by the Committee of Ministers' Rapporteur Group on Legal Co-operation (GR-J) on 12 December 2013.

Dates of the next meetings

- 37. The DH-BIO agreed to hold:
 - its 5th plenary meeting from 5-7 May in Strasbourg. The Conference to launch the Guide on the decision-making process regarding medical treatment in end-of-life situations would be held on 5 May under the Austrian Chairmanship of the Committee of Ministers;
 - its 6th plenary meeting from 12-14 November 2014 in Strasbourg.

Equality between women and men

38. Dr Béatrice Ioan (Romania), Gender Equality Rapporteur within the DH-BIO, informed the Committee about the discussions that took place during the training day for Gender Equality Rapporteurs and the exchange of views with the Gender Equality Commission (GEC), organised on 12-13 November 2013.

Other business

Male circumcision and Article 6 of the Convention on Human Rights and Biomedicine

- 39. Following a request made by the General Secretariat, delegations had been invited, at the last plenary meeting (May 2013), to send information on the legal situation in their respective countries on the issue of male circumcision. All the delegations having sent such information had agreed to it being made public
- 40. The DH-BIO noted that, in the information sent, many countries pay attention to the conditions under which the intervention is carried out so as to minimise the risks for the health and well-being of the child.
- 41. The DH-BIO took note that the Secretariat would send a comment to inform the Secretariat of the Committee of Ministers about this aspect, which the latter might wish to take into consideration when preparing the draft reply to PACE Recommendation 2023 (2013) on children's right to physical integrity.

Cooperation with National Ethics Committees

- 42. The DH-BIO took note of the suggestions made by delegations concerning the possibilities for closer cooperation with National Ethics Committees.
- 43. The Bureau would consider this question and, if appropriate, make (a) proposal(s) to the DH-BIO at its next plenary meeting.

Co-operation with other committees

Consultative Committee of the Convention for the Protection of Individuals with regard to Automatic Processing of Personal Data (T-PD)

- 44. The DH-BIO was informed of the work in progress by the T-PD, as well as the wish of this committee to cooperate more closely with the DH-BIO on issues concerning health-related data.
- 45. The DH-BIO planned to hold a joint meeting of its Bureau and that of the Consultative Committee of the Convention for the Protection of Individuals with regard to Automatic Processing of Personal Data (T-PD) in order to examine how to strengthen cooperation between the two committees, in particular for the purpose of the re-examination of Rec(97)5 on the protection of medical data.

European Committee on Organ Transplantation (CD-P-TO)

46. In response to the request by the CD-P-TO, the DH-BIO expressed its interest to be associated with the reflection engaged by the CD-P-TO on the issue of donation in the framework of end-of-life care, including the hearing foreseen on this topic.

Drafting Group on the Human Rights of Older Persons (CDDH-AGE)

47. The DH-BIO was informed that the Steering Committee for Human Rights (CDDH) had approved the same week the draft Recommendation on the human rights of older persons which would be transmitted to the Committee of Ministers for adoption.
