LANDSCAPE AWARD OF THE COUNCIL OF EUROPE

- Report of the Meeting of the Jury -

1st Session

Palais de l'Europe, Council of Europe, 7 May 2009

The CDPATEP is invited, on the basis of the decisions of the Jury of the 1st Session of the Landscape Award of the Council of Europe (meeting held in Strasbourg, Palais de l'Europe, on 7 May 2009), to address its proposals concerning the award winner and the attribution of special mentions, to the Committee of Ministers.

I. WELCOME AND OPENING OF THE MEETING

1. Mrs Maguelonne DEJEANT-PONS, Head of the Cultural Heritage, Landscape and Spatial Planning Division, welcomed the Members of the Jury to the 1st Session of the Landscape Award of the Council of Europe, who are listed in Appendix 1 to this report, and thanked them for their participation in this meeting.

II. ELECTION OF THE CHAIR

2. The Members of the Jury elected Mr Enrico BUERGI, Landscape Architect and Former Chair of the Council of Europe Conference of the European Landscape Convention, Chair of the Jury of the 1st Session of the Landscape Award of the Council of Europe. The Chair warmly welcomed and thanked all the Parties to the Convention which had contributed with enthusiasm to this first Session of the Landscape Award.

III. PRESENTATION OF THE PROJECTS

- 3. Mrs Maria SCHILLER, Expert of the Council of Europe, presented the complete files received by the Secretariat of the Council of Europe on 31 December 2008 in view of the 1st Session of the Landscape Award of the Council of Europe (2009):
- the "Czech Tourist Club" Czech Republic;
- "Landscape Management of Hämeenkyrö National Landscape Area" Finland;
- "Le Parc de la Deûle, Lille Métropole" France ;
- "Implementation of Complex Nature conservation and Landscape Management Programme in Zámoly Basin" – Hungary;
- "The Val di Cornia Parc System" Italy;
- "Regional Distribution of Landscape Types in Slovenia" Slovenia;
- the "Parque Christina Enea, San Sebastián" Spain;
- the "Biodiversity and Natural Resources Management Project" Turkey.

IV. DISCUSSIONS AND DECISION OF THE JURY

- 4. After deliberation, the Jury decided to:
- attribute the Landscape Award of the Council of Europe of the European Landscape Convention for the 1st Session of the Award (2009) to the : "Parc de la Deûle, Lille Métropole",
 - considering that the realisation fulfils the criteria for the attribution of the award concerning sustainable territorial development, the exemplarity, public participation and awareness-raising.
 - bearing in mind the success of the links between urban space and rural space, as well as the important commitment of all those involved in the cleaning up and new use of the landscape.
- attribute a special mention of the Landscape Award of the Council of Europe's European Landscape Convention for the 1st Session of the Award (2009) to the "Parque Christina Enea, San Sebastian",
 - considering that the realisation answers the four criteria for the attribution of the award as regards sustainable territorial development, the exemplarity, public participation and awareness-raising,
 - acknowledging the excellent results of the long-term planning carried out with a view to the qualitative promotion of the urban landscape whilst bearing in mind socio-cultural elements.

- attribute a special mention of the Landscape Award of Council of Europe's European Landscape Convention for the 1st Session of the Award (2009) to the "Regional Distribution of Landscape Types in Slovenia",
 - considering the exemplarity of the realisation which provides a methodological framework for landscape management at national, regional and local levels, and
 - recognising the use of the instrument which encourages highlighting the diversity of landscapes for the public;
- congratulate warmly those involved in implementing the projects and realisations linked to the following dossiers: the "Czech Tourist Club"; "Landscape Management of Hämeenkyrö National Landscape Area"; "Implementation of Complex Nature Conservation and Landscape Management Programme in the Zámoly Basin"; "The Val di Cornia Parc System"; the "Biodiversity and Natural Resources Management Project",
 - considering their importance with a view to implementing the European Landscape Convention.

V. GENERAL OBSERVATIONSS

- 5. The members of the Jury:
- were pleased at the good organisation of the meeting;
- considered that the Landscape Award of the Council of Europe constitutes an important mean of promoting awareness-raising of the landscape dimension, according to the provisions of the European Landscape Convention and that it would be useful for all Parties to participate in the 2nd Session which will be organised in 2011;
- considered that it was necessary for a diploma to be prepared with the "Council of Europe-European Landscape Convention" logo and also for a leaflet with all the applications to be prepared;
- considered that it would be useful, on the occasion of the next sessions of the award, if:
 - the application dossier could present clearly a description of the territory concerned before and after the realisation presented;
 - the application dossier gave information on the social perceptions of the project and of the opinions expressed about it;
 - the scales could be selected to ensure better understanding of the elements of the project and that subjects concerning the future of landscapes could also be taken into consideration;
 - the projects realised could, where necessary, be seen by members of the Jury.

VI. CLOSING OF THE MEETING

6. The Chair thanked the Members of the Jury for the quality of their contributions and brought the meeting to a close.
