REPORT OF THE 1<sup>ST</sup> MEETING OF THE CJ-S-CH







#### LIST OF DECISIONS

At its first meeting, the Group of Specialists on child-friendly justice (CJ-S-CH), in accordance with its terms of reference,

### took note of:

- the provisional version of the compilation of legal texts prepared by the Secretariat which will be finalised in time for the next meeting of the Group;
- the current drafting, under the aegis of the Programme "Building a Europe for and with children", of the Council of Europe's Guidelines on the elimination of violence against children expected to be adopted in the form of a Recommendation by November 2009, and welcomed the invitation made to the Group to participate in the consultation process on these draft Guidelines at a high level conference planned for 2-3 June 2009 in Strasbourg;
- the Council of Europe's activities on children's participation, including the forthcoming setting-up of a group of experts to develop Council of Europe's guidelines on children's participation and the recent establishment of an internal Council of Europe's Task Force in which the CJ-S-CH's Secretariat is involved;

#### considered:

- how best to prepare the European Guidelines on child-friendly justice and agreed on a list of topics to be addressed in the Guidelines;

#### invited its members to:

- send their profiles to the Secretariat for publication on the website of the Group;
- provide the Secretariat with examples of research findings and examples of good practice to be published on the website and used by the scientific expert;

## instructed the scientific expert to:

- prepare the preliminary draft Guidelines and explanatory memorandum, along the lines agreed at the meeting and incorporating the points made during the discussions;
- prepare, possibly in co-operation with the European Network of Ombudspersons for Children (ENOC), a discussion paper on the draft Guidelines for consultation of children and young people;

#### instructed the Secretariat to:

- write to member states and leading international NGOs and other stakeholders, outlining the task the Group is undertaking, informing them about the consultation process and asking for examples of good practices;
- revise Document CJ-S-CH (2009) 7 BIL enclosing "Proposals concerning the consultation process on the draft guidelines" so to take due account of the views expressed during the discussions;
- post the draft preliminary Guidelines prepared by the scientific expert on the CJ-S-CH's website after the 1st meeting of the Group so that its members can share comments on it before their next meeting;
- forward the draft Guidelines to the CDCJ, CDPC and CDDH in due time and to keep their respective Secretariats informed of the progress made by the Group in its work;

#### decided to:

- hold its 2<sup>nd</sup> meeting on 28-30 September 2009, a hearing with leading international NGOs and other relevant stakeholders specialised in children's rights on 7 December 2009 and its 3<sup>rd</sup> meeting on 8-10 December 2009 in Strasbourg.

#### **INTRODUCTION**

1. The Group of Specialists on the child-friendly justice (CJ-S-CH) held its first meeting in Strasbourg on 16-17 April 2009, with Mr. Seamus CARROLL as Chair and Ms Ksenija TURKOVIĆ as Vice-chair. The list of participants appears in Appendix I to this report.

## I. OPENING OF THE MEETING

- 2. Mrs. de BOER-BUQUICCHIO, Deputy Secretary General of the Council of Europe, and Mr. Jan KLEIJSSEN, Director of Standard-Setting Activities, were excused. The meeting was opened by Mr. Jörg POLAKIEWICZ, Head of the Law Reform Department, Directorate General of Human Rights and Legal Affairs (DG-HL).
- 3. It was recalled that the work of the Group is ranked as one of the major activities of the Committee of Ministers on children's rights and that it constitutes a core pillar of the Council of Europe's strategy on the rights of the child for 2009-2011.
- 4. Mr. Polakiewicz invited the Group of Specialists, as a starting-point, to take stock of the important material provided by Council of Europe experts' reports and the two high-level conferences held in Stockholm (8-10 September 2008) and Toledo (12-13 March 2009) following the 28th Council of Europe Conference of Ministers of Justice (Lanzarote, 2007) on which occasion the ministers invited the Council of Europe to draft European Guidelines on child-friendly justice (hereafter "the Guidelines"). The Group should make the best possible use of existing international and European instruments as well as of the case-law of the European Court of Human Rights.
- 5. He also underlined that the specialists participate in meetings of the Group in their own capacity, as independent experts, and not as representatives of their respective governments. Nonetheless, they are welcomed to liaise with their national authorities to ensure the successful adoption of the text by the Committee of Ministers and its subsequent effective implementation by the member states.
- 6. Mr. Carroll stressed the importance of the structure of the future guidelines as well as of their concrete and practical nature. In this view and in order to ensure their endorsement by all 47 member states, extensive reference to the case-law of the European Court of Human Rights and to examples of good practice should be encouraged and incorporated in the future text.

# II. ADOPTION OF THE AGENDA

7. The agenda was adopted as set out in Appendix II.

# III. INFORMATION BY THE SECRETARIAT

8. Mrs. Regina JENSDOTTIR, Head of the Public and Private Law Division, recalled the terms of reference of the Group as well as the relevant reference documents made available, and gave background to the Group. The latter includes a new integrated working method involving three major Council of Europe's intergovernmental

committees dealing with civil and administrative law (European Committee on Legal Co-operation (CDCJ)), criminal law (European Committee on Crime Problems (CDPC)) and human rights (Steering Committee for Human Rights (CDDH)), as well as consultation of the European Commission for the Efficiency of Justice (CEPEJ).

### IV. INTRODUCTION OF SPECIALISTS

- 9. The Chair welcomed the Group members and observers and introduced the Scientific Expert, Ms Ankie VANDEKERCKHOVE, then Flemish Commissioner for Children in Belgium, who is assisting the Group in its work. The composition of the CJ-S-CH appears in document CJ-S-CH (2009) 4 BIL.
- 10. The Secretariat invited the Group to make the best possible use of its multidisciplinary composition in pursuing a comprehensive approach of children's place and voice in justice to the greatest possible protection and promotion of children's legal rights.
- 11. The Group agreed that each specialist would send his or her profile to the Secretariat for publication on the website of the Group.

# V. <u>PRESENTATION OF COUNCIL OF EUROPE REPORTS ON CHILD-FRIENDLY IUSTICE</u>

- 12. Mrs. Ksenija Turković, Vice-chair, Mrs. Stephanie SCHMAHL and Mrs. Ruth FARRUGIA presented their Reports respectively on "Elements for European Guidelines on Child-friendly Justice with Particular Focus on Children's Access and Place in Criminal Justice System" (CDPC (2008) 17 Addendum IV rev), "Meeting the needs of children" (CDDH(2008)009 rev) and children's access to and place in the civil justice system (CDCJ (2008) 26 rev).
- 13. In addition, Mr. Bragi GUDBRANDSSON, the Icelandic member, and Mrs. Marianne NY, the Swedish member, gave presentations concerning the children's houses that have been set up for child victims of abuse in their countries. Mr. Nigel CANTWELL, representing UNICEF, made a presentation focusing on the notion of children's best interests, juvenile justice and the minimum age of criminal responsibility.
- 14. Presentations made available by their authors following the meeting are accessible on the website of the CJ-S-CH.

# VI. PRESENTATION OF THE WORK OF OTHER COUNCIL OF EUROPE BODIES

- 15. Mrs. Lioubov SAMOKHINA, Programme Officer, presented the Council of Europe's Programme "Building a Europe for and with children".
- 16. The Group took note, in this framework, of the current drafting of Council of Europe's Guidelines on the elimination of violence against children, expected to be adopted in the form of a Recommendation by November 2009. It welcomed the invitation made to the Group to participate in the ongoing consultation on these draft Guidelines and to

- be represented at a high level conference planned for 2 and 3 June 2009 in Strasbourg to discuss and approve these draft Guidelines.
- 17. The Group also took note of the Council of Europe's activities on children's participation including the forthcoming setting-up of a group of experts to develop Council of Europe's guidelines on children's participation and the recent establishment of an internal Council of Europe's task force in which the CJ-S-CH's Secretariat is involved.
- 18. Mrs. Montserrat ENRICH-MAS, Head of the Research Division and Library at the Registry of the European Court of Human Rights, delivered a presentation on the place of the child in the case-law of the European Court of Human Rights with reference to the Report prepared by the Registry of the Court on "Access of children to justice specific focus on the access of children to the European Court of Human Rights as well as its case-law related to children's access to national jurisdictions".

# VII. <u>DETERMINATION OF THE SCOPE AND NATURE OF THE EUROPEAN</u> GUIDELINES ON THE BASIS OF THE TERMS OF REFERENCE OF THE GROUP

- 19. The Group took note of the provisional version of the compilation of legal texts prepared by the Secretariat which will be finalised in time for its next meeting.
- 20. The Secretariat presented proposals concerning the consultation process on the draft guidelines (CJ-S-CH (2009) 7 BIL). The list of organisations and bodies to be consulted being indicative, specialists were invited to suggest bodies to add to this list. Suggestions included Defence for Children International (DCI) and professional associations which could be added to the list.
- 21. The Group instructed the Secretariat to write to member states and to leading international NGOs and other stakeholders, outlining the task that the Group is undertaking, informing them about the consultation process and asking for examples of good practices.
- 22. The question of children's participation was discussed and in particular the possibility of indirect consultation of children (by using studies on the experiences of children confronted with the justice system), was examined.
- 23. The Group instructed the Secretariat to revise Document CJ-S-CH (2009) 7 BIL in order to take due account of the views expressed during the discussions and invited the scientific expert to prepare, possibly in co-operation with the European Network of Ombudspersons for Children (ENOC), a discussion paper for the consultation of children and young people on the draft Guidelines.

# VIII. PRELIMINARY IDEAS FOR A DRAFT STRUCTURE OF THE EUROPEAN GUIDELINES ON CHILD-FRIENDLY JUSTICE

24. The Scientific Expert presented preliminary ideas for a draft structure of the European Guidelines on child-friendly justice which were used as a basis for

discussion among the members of the Group on how best to prepare the Guidelines.

# IX. AGREEMENT ON A LIST OF TOPICS TO BE ADDRESSED IN THE GUIDELINES AND SKELETON OF THE DRAFT TEXT

- 25. The Group considered how to best prepare European Guidelines on child-friendly justice and agreed on a list of topics to be addressed in the Guidelines (Appendix III).
- 26. The Group furthermore instructed the scientific expert to prepare preliminary draft Guidelines and explanatory memorandum, along the lines agreed at the meeting and incorporating the points made during the discussions.
- 27. The members of the Group were invited to provide the Secretariat with examples of research findings and examples of good practice so that they could be published on the website and used by the scientific expert.
- 28. The preliminary draft Guidelines were to be posted on the CJ-S-CH's website after the 1st meeting of the Group so that its members could share comments on it before their next meeting.
- 29. The draft Guidelines should also be forwarded to the CDCJ, CDPC and CDDH in due time and their respective Secretariats should be kept constantly informed of the progress made by the Group in its work.

### X. PREPARATION OF THE NEXT MEETINGS

- 30. The Group decided to hold its 2<sup>nd</sup> meeting on 28-30 September 2009 and its 3<sup>rd</sup> meeting on 8-10 December 2009 in Strasbourg.
- 31. In addition, a hearing with leading international NGOs and other relevant stakeholders specialised in children's rights will be held on 7 December 2009 in Strasbourg.
- 32. Document "Work plan of meetings of the CJ-S-CH for 2009" (CJ-S-CH (2009) 2 BIL) will be updated accordingly.
