Summary

At this meeting, the CDDH, in particular:

- (1) concerning the work on the reform of the Court (see item 2 of the agenda), adopted with a view to their transmission to the Committee of Ministers:
 - (i) its Report on the measures taken by the member States to implement relevant parts of the Interlaken and Izmir Declarations (CDDH(2012)R76 Addendum I);
 - (ii) its Report containing elements to contribute to the evaluation of the effects of Protocol No.14 and the implementation of the Interlaken and Izmir Declarations on the Court's situation (CDDH(2012)R76 Addendum II);
 - (iii) draft Protocol No. 15 to the Convention (CDDH(2012)R76 Addendum III) and the Explanatory Report thereto (CDDH(2012)R76 Addendum IV);
- (2) concerning work on Protocol No. 16 to the Convention, provisionally adopted the draft protocol (CDDH(2012)R76 <u>Addendum V</u>) and, after examination, decided to remit the draft Explanatory Report (CDDH(2012)R76 <u>Addendum VI</u>) to the DH-GDR with guidance for its further examination;
- (3) took note of the current work on the accession of the European Union to the ECHR further to decisions by the Ministers' Deputies on 13 June 2012 (see item 3);
- (4) gave guidance for current and future work on the development and promotion of human rights (see item 4) and, in this context:
 - (i) gave guidance for the work of its drafting group on the human rights of older persons (CDDH-AGE);
 - (ii) adopted a feasibility study on corporate social responsibility in the field of human rights with a view to its transmission to the Committee of Ministers (CDDH(2012)R76 Addendum VII);
 - (iii) exchanged views on the feasibility of work on human rights in culturally diverse societies;
 - (iv) gave guidance for the preparation of the report on the implementation of Recommendation CM/Rec(2010)4 of the Committee of Ministers on human rights of members of armed forces;
 - (v) adopted a questionnaire on the implementation of Recommendation CM/Rec(2010)5 of the Committee of Ministers on measures to combat discrimination on grounds of sexual orientation or gender identity

(CDDH(2012)R76 Addendum VIII) and gave guidance for the preparation on the report on the implementation of the Recommendation;

- (5) took note of the current work within the Committee on Bioethics (DH-BIO) (see item 5);
- (6) took note of the current work within the Gender and Equality Commission (GEC), and provided guidance as to priorities and working methods (see item 6);
- (7) confirmed the experts representing the CDDH in other bodies (see item 7 and Appendix III);
- (8) held elections (see item 8 and Appendix IV);
- (9) adopted the calendar of its meetings and of those of its subordinate bodies (see item 9 and Appendix V).

Introduction

1. The Steering Committee for Human Rights (CDDH) held its 76th meeting from 27 to 30 November 2012 in Strasbourg with Mr Derek WALTON (United Kingdom) in the Chair. The list of participants appears at <u>Appendix II</u>. The agenda, as adopted, appears at <u>Appendix II</u>. The CDDH took note of the general background information document prepared by the Secretariat (CDDH(2012)014) and of the report of the last meeting of its Bureau (CDDH-BU(2012)R86).

<u>ITEM 1</u>: OPENING OF THE MEETING, ADOPTION OF THE AGENDA AND THE ORDER OF BUSINESS

- 2. After the adoption of the agenda and order of business, the CDDH:

 - (ii) agreed with the proposals made by the Bureau for a new format of the meeting reports and invited the Secretariat to draft the abridged and final report of the current meeting according to this format;
 - (iii) noted that a presentation of the European programme for Human Rights training for Legal Professionals (*HELP Programme*) will be made to the CDDH participants on Thursday 29 November from 4 to 4:30 p.m.

- 3. It was recalled that, at its 122nd session (23 May 2012), the Committee of Ministers gave detailed instructions to the CDDH for the follow-up to the Brighton Declaration (see CDDH(2012)008) while setting three deadlines (15 April 2013, 15 October 2013 and March 2015) for the completion of the work on various issues, most of them being in addition to the current work foreseen for the Committee of experts on the reform of the Court (DH-GDR) and its drafting Groups in accordance with the terms of reference for the biennium 2012-2013. The CDDH, at its 75th meeting (19-22 June 2012), gave directions to the DH-GDR and its drafting Groups. The document CDDH(2012)009Rev recalls the entrusted issues and the deadlines set by the Committee of Ministers to the CDDH, as well as the tasks distribution decided by the CDDH for the work of its subordinate bodies and the meeting calendar.
- 4. It was also recalled that the DH-GDR held its 2nd meeting, in plenary composition, from 29-31 October 2012. On the basis of work transmitted in September 2012 by its Drafting Groups A and B, it adopted the texts subject to examination by the CDDH with a view to their adoption at the current meeting (see hereafter, *discussion*) and further transmission to the Committee of Ministers. At the same meeting the DH-GDR also:
 - (i) designated the members of its Drafting Group C (Armenia, Bulgaria, France, Greece, Norway, the Slovak Republic and Switzerland), elected Mr Martin KUIJER (The Netherlands) as Chairperson of the Group and gave guidance on its work;
 - (ii) designated an expert consultant (Mr Martin EATON) to draft a toolkit to inform public officials about the State's obligations under the Convention for its Drafting Group D and gave guidance on this work;

- (iii) appointed Ms Natalia SHAKURO (Ukraine) as its Gender Equality Rapporteur.
- 5. Finally, it was recalled that: (i) on 6 November the Secretariat sent to the participants the draft texts concerning reform subject to examination during the current meeting; (ii) in order to facilitate these discussions, and bearing in mind that most of the documents had already been the subject of detailed examination by the plenary DH-GDR and its drafting groups, the Bureau invited CDDH members to submit any amendment proposal to the Secretariat before the meeting or else to come prepared with their written proposals for presentation during the meeting.
- 6. The experts examined proposals for amendment of the various draft texts. The Chairperson of the DH-GDR, Mr Vit SCHORM (Czech Republic), briefly introduced each text.

National reports

7. Concerning the Report on measures taken by the member States to implement relevant parts of the Interlaken and Izmir Declarations, the CDDH wished to emphasise that the recommendations contained in paragraph 153 must be read in the light of paragraph 152 concerning their applicability and intended effect. It also recalled and itself employed the working method of the GT-GDR-A and DH-GDR, which, in conformity with its terms of reference, limited the examples of good practice contained in this report to those found in the previously submitted national reports on implementation.

Effects of Protocol No.14

8. The CDDH examined the draft Report of the CDDH containing elements to contribute to the evaluation of the effects of Protocol No.14 and the implementation of the Interlaken and Izmir Declarations on the Court's situation. During the examination of the text, the Secretariat indicated that certain figures and statistics were updated in consultation with the Court's Registry.

Draft Protocol No. 15

9. Concerning draft Protocol no. 15 and the Explanatory Report thereto, the CDDH gave full consideration to the letter of 23 November 2012 sent by the President of the Court to the CDDH Chairman concerning draft Article 1 of the Protocol. It recalled that the Court had participated in all stages of preparation of the draft text, in accordance with the terms of reference. On this basis, and in the light also of further clarifications provided by Mr John DARCY of the Registry, it carefully re-examined the compromise text presented by the DH-GDR. It decided, in the light of the views expressed by the Court, to clarify in the Explanatory Report that the intention was "to be consistent with the doctrine of the margin of appreciation as developed by the Court in its case-law". Accordingly, the CDDH decided not to amend Article 1 of the Protocol. A written proposal to replace the text of the draft Article 1 with a version containing three

paragraphs did not receive support. On this basis and following examination of all other parts of the two texts, the CDDH adopted draft Protocol no. 15 and the Explanatory Report thereto by consensus as they appear in <u>Addenda III and IV</u> respectively.

Draft Protocol No. 16

10. Concerning draft Protocol no. 16 and the Explanatory Report thereto, the CDDH examined and provisionally adopted the draft protocol as it appears in <u>Addendum V</u>. It noted that, for lack of time at the various relevant meetings of its subordinate bodies, the draft Explanatory Report was in effect being examined by a meeting of national experts for the first time. It was thus premature to adopt it at the present meeting, including for the reason that to do so would not allow the necessary further consultations with national capitals. After a partial first reading, the CDDH therefore decided to remit the draft Explanatory Report, as it appears at <u>Addendum VI</u>, to the DH-GDR for further examination at its next meeting (13-15 February 2013). It decided not to transmit the draft Protocol to the Committee of Ministers until such time as it would also be able to adopt, and transmit, the Explanatory Report. It fully expected to be able to do so at its next meeting (19-22 March 2013), thereby meeting the deadline of 15 April 2013 set out in the decisions of the May 2012 Ministerial Session.

Conclusions

- 11. The CDDH invited the Committee of Ministers to consider its Report on the measures taken by the member States to implement relevant parts of the Interlaken and Izmir Declarations (CDDH(2012)R76 <u>Addendum I</u>) and its Report containing elements to contribute to the evaluation of the effects of Protocol No.14 and the implementation of the Interlaken and Izmir Declarations on the Court's situation (CDDH(2012)R76 <u>Addendum II</u>) and to decide on possible follow-up action.
- 12. The CDDH invited the Committee of Ministers to consider the draft Protocol No. 15 to the Convention² (CDDH(2012)R76 <u>Addendum III</u>) with a view to its possible adoption and to take note of the Explanatory Report thereto (CDDH(2012)R76 <u>Addendum IV</u>).
- 13. The CDDH invited the Committee of Ministers to extend, until the end of 2013, the current deadline of 15 October 2013 for the finalisation of the work concerning paragraphs 9.f)ii), 9.f)iii), 20.c), 20.e), 25.b) and 29.d) of the Brighton Declaration.

<u>ITEM 3</u>: ACCESSION OF THE EUROPEAN UNION TO THE EUROPEAN CONVENTION ON HUMAN RIGHTS

15. Concerning the ongoing work on the accession of the European Union to the European Convention on Human Rights, the CDDH took note of the negotiation meetings held on 21 June 2012, 17-19 September 2012 and 7-9 November 2012. Depending on developments, the CDDH may wish to hold an exchange of views on this topic at its meeting of March 2013.

ITEM 4: DEVELOPMENT AND PROMOTION OF HUMAN RIGHTS

16. As regards ongoing and future work on the development and promotion of human rights, the CDDH gave orientation on the various issues under examination.

4.1 Rights of older persons (CDDH-AGE)

- 17. It was recalled that, at its 74th meeting (7-10 February 2012), the CDDH established a drafting group on the rights of older persons (CDDH-AGE). At the 2nd meeting (24-26 September 2012), the Group discussed and revised a preliminary draft non-binding instrument elaborated by the Secretariat on the basis of the exchange of views and of the guidance provided by the CDDH at the 75th meeting (19-22 June 2012). The Group agreed that the draft instrument should be accompanied with a guide of good practices to be integrated in the text in boxes under each Section of the instrument, for the elaboration of which delegations would be asked to contribute.
- 18. The Chairperson of the CDDH-AGE, Mr Jakub WOLASIEWICZ (Poland) reported on the ongoing work to elaborate a non-binding legal instrument in view of the guidance that the CDDH will provide for future work. The CDDH exchanged views on substance and on form of the instrument, as well as on its future follow-up. As regards substance, the CDDH exchanged views without, however, entering into a drafting exercise at this stage, since it will come back to this issue in June 2013 in the light of the work the CDDH-AGE will carry out in May 2013.

Conclusions

- 19. The CDDH gave the following guidance on the draft non-binding legal instrument in preparation and agreed to come back to this issue at its meeting in June 2013:
 - As regards the <u>contents</u> of the draft instrument in preparation, the CDDH: (a) gave indications for the possible definition of "older persons"; (b) considered that end of life-related issues other than euthanasia and assisted suicide should find their place in the instrument, but that full consistency should be ensured with the work of the DH-BIO; (c) suggested that CDDH-AGE considers the possibility of including provisions on: support for family members and carers beyond the issue of palliative care, private and intimate life of older persons, work-related issues, expansion of the existing provision about availability of palliative care to medical care in general. Delegations wishing to suggest specific drafting proposals may submit them in writing to the Secretariat before the CDDH-AGE meeting in May 2013.
 - As to the <u>form</u> of the instrument, the CDDH asked the CDDH-AGE: (a) to distinguish more clearly between existing obligations and new recommendations in the text; (b) to make suggestions as to the nature of the future instrument; (c) to incorporate examples of good practices in the body of the instrument. All CDDH members and observers were invited to submit examples of good practices for possible inclusion in the draft to the Secretariat by the end of February 2013. The CDDH also instructed the Secretariat to draft the explanatory memorandum to the instrument.
 - As to its <u>implementation</u>, the CDDH left open for the time being what form the follow-up of the future instrument should take.

4.2 Corporate social responsibility in the field of human rights

- 20. It was recalled that, at its 75th meeting (19-22 June 2012), the CDDH instructed the Secretariat to submit a draft study on the feasibility and added value of standard-setting or other work in this field and provided guidance about the elaboration of this draft.
- 21. In order to facilitate the discussion, the CDDH invited the members of the CDDH to provide any proposals for amendment of the document to the Secretariat before the meeting or to present their proposals in writing at the meeting. It recalled that the study should be adopted in November and transmitted to the Committee of Ministers, in order for the latter to give indications about future work.

- 22. The CDDH welcomed the draft study presented by the Secretariat as a good basis for its work. It underlined the importance of the subject and reiterated the need to avoid duplication with already existing standards and ongoing activities at the European and international level. Some delegations noted in particular the importance of the suggestion to look into the issue of access to justice for victims of corporate human rights violations. The CDDH agreed on some amendments to the draft study, in particular as regards the sections on internet governance, children's rights, social rights and the issue of extraterritoriality. It also amended the proposed conclusions.
- 23. The CDDH adopted the study as amended and decided to submit it to the Committee of Ministers for decision about possible follow-up. In this respect, the CDDH noted that further work on this area may not be undertaken only by the CDDH, but also by other Council of Europe bodies.

Conclusions

24. The CDDH invited the Committee of Ministers to consider its Feasibility Study on Corporate Social Responsibility in the field of Human Rights (CDDH(2012)R76 Addendum VII) and to decide on possible follow-up.

4.3 Human rights in culturally diverse societies

- 25. It was recalled that, at its 75th meeting (19-22 June 2012), the CDDH instructed (i) the Secretariat to prepare a preliminary study taking stock of existing instruments of the Council of Europe and other international bodies, and (ii) and decided to hold an exchange of views in November with a specialist on issues relating to human rights in culturally diverse societies. On this basis, the CDDH held a first general exchange of views on the issue, in view of the study on the feasibility and added value of standard-setting work in this field, for the Committee of Ministers, which should be adopted in June 2013.
- 26. The CDDH appreciated the draft preliminary study prepared by the Secretariat, presenting the existing instruments within the Council of Europe and other international bodies. It exchanged views with Ms Eva SMITH-ASMUSSEN, (member and former Chairperson of the European Commission against Racism and Intolerance ECRI).

Conclusions

27. The CDDH decided to examine in June 2013, in view of its adoption, a draft study on the feasibility and added value of standard-setting or other work in this field. It appointed Mr Morten RUUD (Norway) as Rapporteur on this activity. With a view to the preparation of this study, the CDDH gave to the Secretariat and to the Rapporteur the following guidance:

- The focus of the study should be on the added value of any further standard setting or other work in this field, and to this effect it should examine in particular the implementation of existing standards and of the findings of monitoring bodies, the execution of the relevant judgments of the Court, and the area of human rights training and education. In this context, the CDDH stressed the universality of human rights and decided not to focus on standard-setting in respect of the rights of particular vulnerable groups.
- The study should be based on the previous work of the CDDH in this field, in order to identify possible issues which have not yet been covered and, if so, define specific steps to be taken in their respect. In addition, consideration should be given to existing and ongoing work within other sectors of the Council of Europe and in other international and regional organisations, in order to ensure complementarity and avoid any risk of duplication or overlapping in this field. Finally, the CDDH invited member states who have adopted national human rights action plans to forward a copy to the Secretariat along with information on other good practices at national level.

4.4 Follow-up to Committee of Ministers' Recommendation (CM/Rec(2010)4) on the human rights of members of the armed forces

- 28. It was recalled that, at its 1147th meeting (4-6 July 2012), the Committee of Ministers' Deputies instructed the Secretariat of the Council of Europe to elaborate, under the supervision of the CDDH, a questionnaire on the implementation of its Recommendation CM/Rec(2010)4 to member States on the human rights of members of the armed forces, and to transmit it to member States and to other relevant stakeholders. On the basis of this decision, the Secretariat elaborated a questionnaire, which the CDDH adopted by written procedure, and the competent authorities were invited to reply to the questionnaire by 2 November 2012 at the latest.
- 29. The CDDH took note of the 22 national replies received to date to the questionnaire on the implementation of the Recommendation, and underlined the need to receive more replies in order for the analysis of the implementation to be effective.

Conclusions

30. The CDDH encouraged those states that had not yet done so, to submit replies by the extended deadline of 15 December 2012 and gave guidance to the Secretariat on the preparation of the report that the CDDH should examine and adopt at its meeting in March 2013, with a view to its transmission to the Committee of Ministers by 30 June 2013. The CDDH appointed Ms Natalia SHAKURO (Ukraine) as Rapporteur for this

activity. The Secretariat and the Rapporteur were invited to structure the draft report by grouping, if possible, the replies to the questions by theme, and to present the results in a neutral and easily understandable manner. The consultation of individual replies should be possible on the CDDH website, without appending them to the report.

4.5 Follow-up to Committee of Ministers' Recommendation (CM/Rec(2010)5) on measures to combat discrimination on grounds of sexual orientation or gender identity

- 31. It was recalled that, in accordance with the instructions given by the CDDH at its 75th meeting (19-22 June 2012) and following the decisions taken by the Ministers' Deputies at their 1151st meeting (18-19 September 2012), the Secretariat prepared a draft questionnaire on the implementation of Recommendation (CM/Rec(2010)5) on measures to combat discrimination on grounds of sexual orientation or gender identity. The Secretariat sent it³ for adoption through electronic communication. In light of the comments received, the Bureau invited the CDDH to circulate a revised version of the questionnaire to the participants in the CDDH for examination and adoption during the Plenary meeting. This procedure follows an express request made by a delegation, which also wanted to draw various objections of form and substance to the attention of the CDDH.
- 32. During the discussion, two delegations expressed their disagreement with the proposed inclusion in the questionnaire of a section concerning follow-up, arguing that such section went beyond the scope of the review of the implementation of the recommendation requested by the Committee of Ministers. Other delegations disagreed. They underlined that this section was pertinent, that the replies given to these questions did not prejudice any possible decision of the Committee of Ministers in this respect, and that identical questions had been proposed, and accepted without difficulties, when adopting the questionnaire on the implementation of the recommendation on the human rights of members of armed forces. After a vote, it was decided by a large majority to maintain such questions in the text. The CDDH also agreed on a number of amendments to the questions aiming at ensuring full consistency between the questions and the text of the recommendation. It was underlined that the respect of the deadline fixed for the replies would be important given the limited time available for the analysis of the replies and the preparation of the report.

33. The CDDH, after a thorough exchange of views both on the procedure and on the substance, adopted by a large majority⁴ a questionnaire on the implementation of Recommendation CM/Rec(2010)5 on measures to combat discrimination on grounds of sexual orientation or gender identity (CDDH(2012)R76 Addendum VIII) and fixed 31 January 2013 as deadline for the submission of replies to the Secretariat (nicoladaniel.cangemi@coe.int). Two delegations made statements concerning the scope of the questionnaire before and after the vote. They appear in Appendix VI of the present report. The CDDH appointed Ms Liselot EGMOND (The Netherlands) as its Rapporteur on this issue and asked the Secretariat and the Rapporteur to follow the same guidance given under § 30 above for the preparation of the report that the CDDH should examine and adopt at its meeting in March 2013, with a view to its transmission to the Committee of Ministers preferably by 31 March 2013.

4.6 Future work

- 34. It was recalled that, at its 73rd meeting (6-9 December 2011), the CDDH decided that it "could, at [its] 76th meeting (November 2012), hold an exchange of views on issues which should be dealt within the biennium 2014-2015, with a view to making proposals to the Committee of Ministers in good time for their inclusion in the programme of this biennium" (see document CDDH(2011)R73, § 27). In view of this examination, the participants in the CDDH, including the civil society, have been invited to send any proposal to the Secretariat before the current meeting or to come prepared with their written proposals for presentation during the meeting.
- 35. The CDDH exchanged views on possible other priority areas for development and promotion of human rights that may deserve to be examined by the CDDH in the biennium 2014-2015, with a view to the submission of a study and the formulation of proposals to the Committee of Ministers in time for their inclusion in the programme of that biennium.

Conclusions

36. During the exchange of views several themes were evoked by delegations, as well as by the Secretariat. Some of the themes mentioned had already been envisaged or dealt with by the CDDH in the past, such as the detention of irregular migrants, the right to the satisfaction of basic material needs of persons in situations of extreme hardship, and the relationship between human rights and environment – including the impact of climate change on human rights; others were new, such as the impact of austerity measures on the enjoyment of human rights. On the basis of this discussion, the CDDH agreed to have a thorough exchange of views on this issue at its meeting of March 2013. To this aim, it asked the Secretariat to prepare an annotated list of possible themes, taking also into

account the work of the DH-DEV, recent recommendations and ongoing work by the Parliamentary Assembly, and invited delegations to forward possible comments and proposals in this respect to the Secretariat by end-January 2013.

37. The Secretary of the Committee on Bioethics (DH-BIO), Ms Laurence LWOFF, presented the priorities and results expected at the 2nd DH-BIO meeting (4-7 December 2012). She mentioned in particular the work concerning (i) decision-making process related to medical treatment in end-of-life situations other than euthanasia and assisted suicide; (ii) predictivity, genetic testing and insurance; (iii) genetic testing for health purposes; (iv) organ trafficking; (v) clinical trials on medicinal products for human use. Detailed information on the ongoing work can be found in the reference document CDDH(2012)014, §§ 18-24.

Conclusions

38. The CDDH concluded that the current work did not require, at this stage, a particular CDDH decision. It decided to exchange views on this issue at its next meeting in March 2013. It took note, in particular, that one CDDH member will be part of the working Group on an additional Protocol on the protection of the human rights and dignity of persons with mental disorder in regard of involuntary treatment and placement, which will begin its work in April 2013.

39. The Head of the Gender Equality, Violence Against Women and Domestic Violence Division, Mrs Liri KOPAÇI-DI MICHELE, presented the work conducted by Gender Equality Commission (GEC) at its 2nd meeting (14-16 November 2012). She referred in particular to the exchange of views which took place on the feasibility and the added value of possible work on (i) violence against women; (ii) women's access to justice; (iii) gender stereotypes in the media which the GEC identified as priorities in the

short term. Detailed information on the ongoing work can be found in the reference document CDDH(2012)014, §§ 26-28.

Conclusions

- 40. The CDDH confirmed the priorities identified by the GEC and provided guidance on working methods.
 - As to the <u>priorities</u>, the CDDH agreed with the interest in short-term work on the three following questions: (a) women's access to justice, if possible emphasising specific situations such as women in situations of extreme hardship, but highlighting ways in which access may be unequal as compared with that of men in similar circumstances; (b) women in the media (in addition to the problem of stereotypes perpetuated by the media, examining women's access to positions of responsibility in this sector); (c) violence against women and domestic violence.
 - As to <u>working methods</u>, the CDDH encouraged the GEC to propose dates for its meetings allowing the Steering Committee to receive its meeting reports in good time so as to be able to give possible guidance.

47. It was recalled that representatives of the following organisations asked to be allowed to attend some items on the agenda of the CDDH at its 76th meeting (27-30 November 2012): the European Trade Union Confederation (ETUC): items 1, 2, 3, 4, 5 and 6; the Conference of European Churches (CEC): item 4.

Conclusions

- 48. The CDDH authorised representatives of ETUC to attend items 2, 3 and 4 and KEK item 4. Noting that ETUC asked to participate under almost all the items on the agenda, which means in effect asking for observer status, the Bureau recalled that the CDDH had already decided not to give a positive answer to a request aiming at obtaining such status.
- 49. As to future requests for participation on an *ad hoc* basis, the CDDH decided the following procedure: (i) the request should be sent by the Secretariat to all experts of the CDDH for information; (ii) the decision will then be taken by the Bureau.

10.2 Working methods

50. Conclusions

51. The CDDH decided to follow this presentation to reflect its work of this meeting. The CDDH asked the Secretariat to ensure by appropriate means that all CDDH participants have the complete contact details of all other participants at the meetings.

52. Brigitte KONZ (author of notes) participated in part of Session 2 and the Round table. The agenda of the Symposium concerned the following problems:

Introdution:

<u>Session 1</u> - Biobanks : Situation and expectations (overview of the situation regarding research biobanks; public understanding and expectation regarding biobanks);

<u>Session 2</u> - Information and consent as a process (main challenges; information process (quantity, quality, dynamics); « recontacting–consenting again »; protection of vulnerable persons: children);

<u>Session 3</u> - Privacy and data protection (main challenges; limits of anonymisation; transborder flows of samples and accompanying data; right to withdraw consent—right to be forgotten);

<u>Session 4</u> - Responsible governance and use (mechanisms for internal biobanks governance – oversight bodies and independent ethics bodies; access (fairness of access, transparency, criteria, biobank networks); feedback (right/obligation, mechanism). <u>Round-table</u>: debate on key issues identified during the Symposium.

A documentation video of this symposium has been made. This documentation as well as the one of the last symposium on the end of life, are available on the website of the Committee on Bioethics. Of major concern is the protection of privacy regarding the transmission of samples and identifiable data within the transfrontier framework of research, access to this data, control and security of data, follow-up of donors and communication, more specifically information and informed consent, as well as the control of biobanks and/or data by internal and external bodies.

- Consent from the donor at a given time should it be repeated at a stage or stages of the procedure (which could be difficult and costly when data is anonymised or where new research is undertaken?
- Should the donor always be informed on the extend and necessity of this repeated consent and this with regard to scientific and other data which the donor does not necessarily understand and/or does not understand the usefulness or quite simply does not want to know?
- Can the consent be withdrawn?
- The consequences of absence of consent to anonymisation and the impossibility to recontact the donor in cases where the research has revealed important medical information relevant to the donor.
- The risk of absence of control on data when the use of biological samples and personal data is approved and authorised for multiple future research projects of which the goal could still be unknown.
- Should the notion of personal data be limited or the protection rules for such data made more flexible?
- Patient donors, in particular for example those suffering from rare diseases, are
 more interested in their data and samples transmitted and made available to a large
 number of research centres and researchers, thus increasing their chances of
 recovery. They are less worried about problems connected with the transmission
 and protection of their data.

31st Council of Europe Conference of Ministers of Justice Vienna, 19-21 September 2012 - Mr Derek Walton (United Kingdom):

The theme of the meeting was "Responses of justice to urban violence". Discussion was based around two themes: juveniles as perpetrators and victims; and organised groups and their new ways of communicating. Human rights naturally had a prominent place in many interventions. The CDDH's written contribution (adopted at our June 2012 meeting) was conveyed to the meeting and was well received.

The Conference adopted a resolution on responses of justice to urban violence. This can be consulted on the Council of Europe website (www.coe.int). The resolution took account of relevant human rights aspects and, in particular, recalled the European Convention on Human

Rights and expressed the conference's resolve to ensure the human rights of both victims and perpetrators.

The resolution envisages that the CDPC will be mandated to examine ways to promote dialogue and cooperation between law enforcement authorities, telecommunication providers and internet service providers in order to facilitate prevention of urban violence, while guaranteeing full compliance with the ECHR. It is anticipated that CDPC will do this in cooperation with other steering committees, potentially including CDDH.

23rd meeting of the Committee of Experts on Terrorism (CODEXTER) (Strasbourg, 15-16 November 2012) - Ms Isik Batmaz (Turkey):

The Committee of Experts on Terrorism (CODEXTER) held its 23rd meeting on 15-16 November 2012. The following issues were discussed and presentations were made during the meeting:

- The Committee discussed its future priorities which included the issues of, inter alia, terrorism and the internet; radicalization; special investigation techniques; terrorists acting alone; receiving training for terrorism; bringing terrorists to justice.
- A brief presentation regarding the on-going thematic assessment procedure of the Group of Parties was made by its Chair.
- Italian and Norwegian delegates made presentations on a number of concrete examples of terrorism cases dealt with in their countries. The Turkish delegate expressed interest to present a case study during the next CODEXTER meeting.
- The Secretariat made a presentation of the new database on terrorism related case-law of the Court, which is to be reached through CODEXTER's webpage. A working group was established in this respect (delegates of Turkey and Poland) to review and select cases that would be published on the database.
- A presentation was made by Prof. Ana Salinas de Frias regarding her book titled "Counter-Terrorism and Human Rights in the case-law of the European Court of Human Rights", published by the Council of Europe.
- Delegate of Turkey proposed to organize and host a conference in order to provide exchange of views of national coordinating bodies in the field of fight against terrorism.
- The Counter-terrorism coordinator Mr Ivan Koedjikov provided information regarding the organization of an international conference on special investigation techniques within the context of bringing terrorists to justice. The project is to be organised by the Council of Europe in mid-2013, subject to budgetary approval of the Committee of Ministers, in coordination with the United Nations and possible cooperation of OSCE as well as a number of other relevant international organisations.
- Delegations of Norway and the Netherlands made presentations concerning measures envisaged to be taken in their countries with regard to terrorists acting alone, such as criminalization of intent and preparatory acts to commit terrorist acts beyond reasonable doubt. The Committee further discussed the possible steps that can be taken for the criminalization of receiving training for terrorism.
- The Chair and Secretariat were instructed to prepare proposals on how to extend the existing co-operation with the EU in respect of terrorism related issues.
- Delegates of Austria, Belgium, Czech Republic, Greece and Hungary made presentations on updated country profiles on counter-terrorism capacity and information on measures taken at national level against terrorism in their respective countries. Presentation regarding the country profile of Georgia was postponed.

- Presentations were made by the Permanent Representative of Switzerland as well as by representatives of the United Nations Counter-Terrorism Committee (CTED); the Action against Terrorism Unit of the OSCE; Human Rights Department (ODIHR) of the OSCE; Case Analyses Unit of Eurojust; and Terrorism Prevention Branch of the UNODC regarding recent work on prevention of terrorism in their respondent fields. Furthermore an expert who represented the CODEXTER at the Gender Equality Commission briefed the group about the discussions in that meeting.
- Terms of office of the Chair and the Vice-Chair were renewed for one more year in accordance with the Resolution (2011)24 of the Committee of Ministers.

The CODEXTER shall have its next meeting on 16-17 May 2013.

Appendix VI

Declaration of two Delegation concerning the questionnaire on the follow-up of Recommendation CM/Rec(2010)5 of the Committee of Ministers on measures to combat discrimination on grounds of sexual orientation or gender identity

BULGARIA

This delegation abstained in the vote for the reasons stated in the plenary discussion yesterday, namely we consider that the Follow up section of the Questionnaire goes beyond the scope of the decision of the Deputies.

We fully recognise our responsibility to guarantee equal enjoyments of rights and freedoms to all individuals. In recognising this responsibility Bulgaria is among the first countries which have introduced legislative measures to combat discrimination including explicitly on the ground of sexual orientation or gender identity.

Our only matter of concern with the Questionnaire is the Follow up section to be included in it at this current stage. The periodical review is rather meaningless at this stage since the measures require time to be implemented and assessed and decisions to be taken how amend or complement these measures.

Attention should also be paid to the point to the need to avoid duplication of work raised on many other issues in this Plenary- in the Recommendation itself the role of the Commissioner for Human Rights in monitoring the situation of LGBT persons in the member states is mentioned with appreciation and in addition to this monitoring the members states are also subject to the UPR where the LGBT issues are part of the screening.

RUSSIAN FEDERATION

The Russian Federation respects and takes measures to uphold equal rights without discrimination for all human beings in accordance with Article 14 of the European Convention on Human Rights and Fundamental Freedoms, as well as the principle of the best interest of the child in all decisions concerning children.

The Russian Federation views Recommendation (2010)5 in light of the interpretative statement made by its Permanent Representative at the time of the adoption of this Recommendation, and takes into account the statements made by 7 other Member States at that time. In particular, it notes that the Recommendation did not reflect a consensual position among all Member States, and that the subsequent Thematic Debate in the Committee of Ministers on the topic of LGBT revealed significant divergence of positions on this matter.

The Questionnaire on the implementation of this Recommendation by Member States contains several provisions in the "Follow-up" section which manifestly go against the mandate issued to the CDDH by the Committee of Ministers in its Decision of 19

September 2012. The Committee of Ministers never asked the CDDH to re-evaluate any provisions of the Recommendation or its Appendix, or to reflect on the need for such re-evaluation. Neither did it ask to conduct a periodic review of the implementation of the Recommendation, nor to evaluate the need for such a review.

On this basis, the Russian delegation had proposed to amend the draft questionnaire accordingly. These proposals, however, had not been taken on board.

In the context of the above the Russian delegation is against the adoption of the Questionnaire in its present form.
