#### Context

- 1992: entry into force of CRC in BE
- 1996: great child abuse case 'D'
- 1997: fundamental reforms in Flanders: Children's Rights Commissioner/ Child Impact report/ Governmental policy
- Succeeding policy plans with attention to violence against children and child abuse
- Cooperation between federal & regional level
- General expertise of Sensoa, the Flemish expertise centre for sexual health
- Youth organizations with specific expertise on youth and sexuality

#### Recent problems of child abuse

- Cases of sexual abuse connected to the Catholic Church
- Concluding observations CRC
- Study on violence that children experience in daily life (home, at school and in their free time) carried out by the Flemish Children's Rights Commissioner
- Study "Sexpert" about the sexual health of the population in Flanders
- Facts on child abuse

#### Facts – contexts – risks

- 1/5 girls and 1/10 boys confronted with SAB (Sexual abusive behavior)
- 1/10 girls rape or attemption to rape
- 1/3 is more than once
- Contexts:
  - 33% at school,
  - 10% in sport organizations,
  - 7% in the family and
  - 3% in youth organizations

Risks: background, attitudes, social context.

The Protective factor is a good relationship with parents

### Cross-sectoral approach

- Answer of Flemish government (sept 2011):
  - Not the problem of one sector
  - Cross-sectoral: day care, youth help, schools, sport and youth work
  - Cooperation with federal (Justice & police)
  - Declarations of engagements minister/ sector
  - Training
  - Contact point to report cases of violence (tel. 1712)

#### Declaration

- Between minister and resp. sector (day care, youth help, schools, sport and youth work)
- Flemish Parliament, Febr. 2012
- 38 Youth organizations
- Engagement to protect the sexual and bodily integrity of children from a positive view on sexuality and relations
- Development of specific instruments for the resp. sectors
- Financial support
- Annual follow-up

- Roots: the fundamental principles



# Flag system "(N)iets mis mee?!"= "Nothing/ Something wrong?!"



### "Nothing/ Something wrong?!"

- Adaptation of the Flag system of Sensoa for youth organizations
- Practical instrument on sexual colored situations
- 36 situationcards with drawings, a classification, suggestions for reaction and links to organization policy
- Training of the trainers by Sensoa so that training can be given by youth organizations themselves (Jong & Van Zin)

#### Purpose Flag system

- Sexual behavior of children: judging correctly
  - Objective and neutral
  - > Criteria and arguments
- Stimulating communication
  - > Nuance and normalising
  - > Shared language
- Pedagogical reaction
  - > Instruments and methods
  - > Examples

#### 6 criteria

- 1. Mutual consent: we both want it
- 2. Voluntarily: no coercion or pressure
- 3. Equality: equal in development
- 4. Age and development normative list
- 5. Context: not disturbing to others
- 6. Self-respect: not self-harming

## Steering wheel





## How to judge?


- Green flag: acceptable and positive sexual behavior (age- and developmentally appropriate)
- Yellow flag: occasional light SAB (mildly unacceptable)
- Red flag: troubling SAB (seriously unacceptable)
- Black flag: severe SAB (severely unacceptable)

#### Reactions

- Always start with telling what you hear, see.
- Get a good picture: ask open questions.
- Always explain
- Reaction
  - Green: accept, explain or ignore
  - Yellow: accept, limit, explain, give alternatives
  - Red: accept, forbid, explain, control
  - Black: forbid, explain and prevent in the future (take measures)



- A girl of 4 gives her brother of 5 a kiss on the mouth.
- Green



Two boys of 14 have a sleepover. They show their erections.
Green

- Two girls of 13 are sitting in the bedroom. They caress each other between the legs, and they like it.
- Green





- A boy of 10 pressures a girl of 10 to give him a blow job.
- Red


- A group of 17 year old boys masturbate together. They have fun.
- Green (if voluntary)







- A teacher bends over a pupil of 15 years old
- Yellow

- A mother washes the private parts of her 12 year old son, because she wants him to be sane.
- Red





- A boy of 15 shows his penis in front of the webcam.
- Yellow (peers)/ red





- + Adolescents 12 -16
- + 30 drawings
- + Cards: did you know, support, acceptable or not

- Get sexuality out of the taboo sphere
- Have a positive view on sexual and bodily integrity of children, sexuality and relations
