Activities table

The Council of Europe Inter-Secretariat Task Force on Children's Rights is entrusted with the mission of facilitating the mainstreaming of children's rights in all Council of Europe's policies and of supporting the coordination of all its actions in the field of children's rights.

This document provides an overview of the Council of Europe activities on the rights of the child during the period 2012-2015. It gathers activities implemented and planned by the Children's Rights Division, joint activities with other entities within the Council of Europe and activities implemented by other sectors of the Organisation. For some of the joint activities, the Children's Rights Division has an advisory or supportive role, whereas for others it is actively involved in the implementation itself.

The activities are grouped in accordance with the four strategic objectives set forth within the 2012-2015 Strategy for the Rights of the Child.

The activity table is a living document regularly updated by the Children's Rights Division. Its purpose is to favour information sharing, offering a clear overview of each Council of Europe sector or body to the implementation of the Strategy on the Rights of the Child.
