## Answers in respect of the 9th report of Slovenia

#### Article 4/1

According to the old standard classification of activities (SKD) gross wage in the private sector represents activities from A to K. We assume that the requested gross average wage in the economy equals activities from A to O (Whole economy) as included in the following table:

## Questions in respect of the 9th report of Slovenia

### Article 4§1

- Is the "gross wage in the private sector", as presented in the report, representative of the gross average wage in the economy? If yes, what is its net value? If not, please provide information on the national net average wage.
- The value of the minimum wage in 1998-2000 as provided in the report is different from the values indicated in the report of 2002 for the same years: e.g. in 1998 the current report quotes 63,285 tolars as the minimum wage whereas the 2002 report quoted 64,666 tolars as the net minimum wage. What is the reason for this difference? What was the net value of the minimum wage in the reference period (2005-2008)?
