Reference is made to your letter of the 26th May 2009 and the question in respect of the 2nd report of Malta.

Article 13§2:

"LN 85 of 2007 Equal treatment of Persons Order" covers discrimination in political and social rights on the grounds of social status. In fact article 4 (1) inter alia states that "No person, establishment or entity, whether in private or public sector and including public bodies, shall discriminate against any other person in relation to:

- (a) social protection, including social security and healthcare;
- (b) social advantages;
- (c) education;
- (d) access to and supply of goods and services which are available to the public, including housing;
- (e) access to any other service as may be designated by law for the purpose of this regulation.

Therefore from the above it is amply clear that Malta is in conformity with the said article.
