Career soldiers (serving in the German Bundeswehr) may at any time request to be discharged from the Bundeswehr (section 46, paragraph 3, sentence 1 of the Legal Status of Military Personnel Act - SG). In the case where a career soldier's military training was combined with university education or professional training, discharge is possible only after a subsequent period of service of at least three times the duration of the soldier's university studies or professional training, but not later than after a period of ten years (Stehzeitverpflichtung - obligatory period of service). Career soldiers shall, upon their request, be discharged before the end of their obligatory period of service, if the continuation of service were to constitute a special hardship for personal, in particular domestic, professional or economic reasons (section 46, paragraph 6 of the Legal Status of Military Personnel Act).



Questions addressed to Germany

Article 1§2 (prohibition of discrimination in employment/ forced labour/ right to earn one's living in an occupation freely entered upon):

- What is the length of, if any, compulsory minimum period of service required of those serving in the professional armed forces?
- Are there circumstances, such as specialised training or specific operational requirements, which entail a different compulsory minimum term of service in the professional armed forces and under what conditions may the persons concerned leave the service before the expiry of this term?
