Regarding the reply of Greece to the additional questions made by the European Committee of Social Rights during the examination of the 19th Greek Report on the implementation of the European Social Charter, concerning article 13§4 of the Charter that secures the right to social and medical assistance, we inform you of the following:

The entitlement to emergency social assistance, (i.e. food, shelter, clothing) in case of need both for persons who are lawfully present in Greece (students, tourists, etc) as well as for persons who are unlawfully present, including those whose applications for refugee or stateless person status have been rejected as well as others, is examined case by case. For example, assistance is offered to all persons without exception in cases of natural disaster as well as to all unattended – under aged children irrespective of their nationality.

Furthermore, medical services are offered in emergency cases until the health status of the affected persons is stabilized. These services are also offered to under aged children whether in emergency cases or not, while in cases of massive arrivals of illegal immigrants, patients are transferred to proper medical units for hospitalization.

Question in respect of the 19th report of Greece

Article 13§4:

The Committee recalls that under Article 13§4 of the Charter, legislation or practice which denies entitlement to emergency medical assistance to foreign nationals, within the territory of a State Party, even if they are there illegally, is contrary to the Charter ((International Federation of Human Rights (FIDH) v. France, Complaint No.14/2003, decision on the merits of 8 September 2004).

The Committee asks whether the following categories of foreign nationals are eligible for emergency <u>social</u> assistance (e.g. food, shelter, clothing) in case of need:

- lawfully present in Greece (e.g. students, tourists etc);
- unlawfully present, including those whose applications for refugee or stateless person status have been rejected as well as others.
