#### Council Conclusions

- Concrete actions to be taken by the Member States:
  - Gender equality institutional mechanisms located at highest possible level;
  - sufficient personal resources, clearly defined mandates and relevant powers and resources to fulfil the mandate;
  - existence and usage of easily applicable tools and methods for gender mainstreaming;
  - coordination of activities, synergies of efforts, involvement of social partners;
  - awareness raising and strengthened knowledge in gender equality and gender mainstreaming.

 Improving the production, dissemination and use of comparable, reliable, regularly updated statistics disaggregated by sex in all relevant areas, in particular where this data is still missing
