#### *Issues to be addressed:*

The initial presentations and the subsequent discussions will focus on best practices and difficulties encountered in the process of drafting legislation on property restitution/compensation. The need to carry out an impact assessment before drafting legislation on property restitution/compensation should be addressed by the participants, who are invited to share their experiences in this respect. The presentations should give an overview of the various solutions that may be envisaged (restitution and/or compensation), the institutional set-up and the systems of property registration and evaluation. It is also expected that the speakers address the modalities of the award of compensation (in-kind and financial), in particular the eligibility criteria, the level of compensation (full market value or capped compensation) as well as the form of payment (single payment or installments). The issue of judicial review of the administrative decisions on property restitution/compensation is equally of interest. The speakers are also invited to share their experience of the execution of judgments of the European Court of Human *Rights in the field of property restitution/compensation.*

#### Issues to be addressed:

The initial presentations and the subsequent discussions will focus on best practices and difficulties encountered in the implementation of the relevant legislation and issues that arise in the process of property restitution/compensation. Measures related to the modalities of awarding compensation (in-kind and financial) and to the payment of compensation - in particular, measures taken to ensure appropriate funds for the award of compensation and difficulties encountered in this respect - should be shared with the participants. The experience of the setting-up of and functioning of institutions in charge of the property restitution/compensation should also be discussed. The competences of such bodies, the relevant procedures and the availability of human and financial resources should be addressed. It is also expected that the participants share their respective experience on the interpretation of the legislation relating to the property restitution/compensation by the administration and domestic courts. The speakers are also invited to share their experience of the execution of judgments of the European Court of Human Rights in the field of property restitution/compensation.
