¹ In addition to the above figures, the Russian authorities indicated that 4 events took place in the "specially designated area" for holding public events in St Petersburg without prior request made and authorisation given. In this context, it is recalled that "specially designated areas" for holding public events are places for which no prior notification must be given to the competent authorities, as per national legislation, in order to hold public events there. Accordingly events planned to be held in such places are to be distinguished from events planned to be held in other places for which prior notification must be given.
