Many EU countries regretted this, while the EWL and UN Women pointed to the lack of coherence of the EU: while lobbying hard for a standalone goal on gender equality in the post-2015 negotiations, the EC is not so forthcoming about an "intra-EU" policy document on how to achieve it in EU countries. (we follow developments closely)
