#### Item 4 1st Evaluation Round, 1st Group: follow up to the final GRETA report on Denmark

GRETA noted with concern that the Danish authorities had not submitted comments to GRETA's final report on Denmark. GRETA decided to exceptionally extend until 19 December 2011 the deadline given to the Danish authorities to submit comments and, after this date, to proceed with the publication of the report on Denmark even in the absence of comments.

GRETA adopted the final report on Georgia as amended in the light of the comments received from the Georgian authorities. GRETA decided to send the report to the Georgian authorities and to invite them to submit their final comments within one month. At the expiry of this time-limit GRETA's report, together with eventual comments received from the Georgian authorities, will be made public.

#### Item 9 1st Evaluation Round, 1st Group: adoption of the final GRETA report on Moldova

GRETA adopted the final report on Moldova as amended in the light of the comments received from the Moldovan authorities. GRETA decided to send the report to the Moldovan authorities and to invite them to submit their final comments within one month. At the expiry of this time-limit GRETA's report, together with eventual comments received from the Moldovan authorities, will be made public.

# Item 10 <u>1st Evaluation Round, 1st Group: adoption of the final GRETA report on Romania</u>

GRETA noted with concern that the Romanian authorities had failed to provide on time their comments to the draft report on Romania, and decided to postpone the discussion of the final report on Romania until the next GRETA meeting in March 2012. GRETA decided to send a letter to this effect to the Romanian authorities, asking them to provide their comments at the latest by 15 January 2012.

In order to follow up on the work of the informal working group on ensuring consistency in the interpretation of the Convention, GRETA decided to set up thematic working groups dealing with specific issues related to its work, in particular concerning mechanisms for the referral of victims of trafficking, tools and checklists for ensuring consistency in GRETA's evaluations, and legal issues related to the interpretation of the Convention.

### Item 16 Stocktaking of the evaluations of the 1st group of 10 parties

GRETA decided to shorten the time period for Parties to respond to its questionnaire with a view to ensuring that evaluations are completed expeditiously. It was agreed that the questionnaire will be sent to the 3rd group of Parties to the Convention on 1 February 2012 and the deadline for responding will be 1 June 2012.

Item 17 <u>Exchange of views on the follow-up to be given to GRETA's evaluation reports</u>

GRETA decided to hold a meeting in September 2012 to discuss the follow-up to be given on its evaluation reports.

Item 18 <u>Exchange of views on the non-punishment of victims of trafficking in human beings</u>

GRETA decided to continue the exchange of views on the issue of non-punishment of victims of trafficking in human beings during future meetings.

Item 19 <u>Exchange of views on data collection</u>

GRETA decided to include an introductory paragraph to the section on data collection and research on GRETA evaluation reports.

Item 20 1st Evaluation Round, 2nd Group: preparation of forthcoming country visits

GRETA decided that the country visits to Malta, Latvia and Portugal will take place in the first quarter of 2012, and the country visits to Bosnia and Herzegovina, France, Norway and Poland, in the second quarter of 2012.
