It was decided that the new Bureau's term of office of two years would start on 1 January 2011.

GRETA noted with satisfaction that the Council of Europe's 2011 budget provided for two additional posts for the Anti-Trafficking Secretariat (one administrator and one assistant) and decided to review the staffing situation at its meeting in June 2011. GRETA was concerned that the budget allocated to its activities in 2011 might not enable it to effectively carry out the first round of the evaluation of the implementation of the Convention.

GRETA welcomed the election of two new GRETA members, Mr Helmut SAX (Austrian) and Mr Jan VAN DIJK (Dutch).

GRETA was pleased to note that, since its last meeting, the Convention had been ratified by three Council of Europe member states (Italy, San Marino and Ukraine), bringing the total number of ratifications to 33. GRETA once again urged the Council of Europe member States which had not already done so, the non-member states which had participated in the preparation of the Convention, and the European Union, to sign and/or ratify the Convention. In addition, GRETA reiterated its call for other non-member states to accede to the Convention.

GRETA decided to follow closely the implementation of the Paris Declaration (adopted by the participants in the conference "Parliaments united against trafficking in human beings" organised by the Council of Europe Parliamentary Assembly on 3 December 2010), which it welcomed.
