The court applied discretionary mitigation on the grounds of the police officer's good behavior during hearings, negative effects of a possible imprisonment sentence on his career, his positive criminal record and a friendly settlement reached between the applicant and the police officer. The court consequently suspended the pronouncement of the sentence for five years.

However, the court suspended the pronouncement of the sentence for 5 years on account of the fact that the police officer did not have any previous criminal record and that he was unlikely to commit another crime. No information has been provided as to whether appeal proceedings were lodged before the Court of Cassation.
