We hereby inform you that you have been selected to participate in a workshop on gender perspective, human trafficking and sexual exploitation.

This program has been designed in compliance with the international commitments assumed, especially with section 8c of the Inter-American Convention on the Prevention, Punishment and Eradication of Violence against Women (Belem do Pará) because it establishes that the State Parties will promote "...the education and training of the staff from the Administration of Justice, Police and other public officials in charge of law enforcement..." and with sections 2 and 6 of the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) because they establish respectively that the State is committed to:

- Enshrine in their National Constitutions and in any other appropriate legislation, if they had not yet done so, the principle of equality between men and women, and to ensure by law, or any other appropriate means, the practical realization of that principle;
- The adoption of the appropriate any form of discrimination against women;
- The legal protection of the right to a fair trial by competent courts and other appropriate means;
- Refrain from committing any act that discriminates against women and to ensure that their institutions act according to that principle;
- Take all the appropriate measures to prevent discrimination against women;
- Adopt all the appropriate measures that constitute a discriminatory practice against women;
- Repeal any criminal national laws and measures... to suppress all forms of violence against women.
