The Bureau is invited to review the state of implementation of its work programme.

Introduction

At its 3rd meeting (Strasbourg, 19-21 March 2014), the CDCPP "took note of the information provided in document CDCPP(2014)6 on the 2014-2015 work programme and proposed including information on indicators, a time line and budget for each activity. For the future, the Committee recommended discussing first the achievements in the previous biennium in order to better identify priorities and challenges" [Abridged meeting report, CDCPP(2014)20].

The Secretariat has prepared this working document as a tool to enable the CDCPP to have an overview of the tasks it has been given and the means of implementing them. Some of the activities mentioned in the following pages are the result of specific decisions by the Committee of Ministers (*ad hoc* terms of reference). In other cases, it is up to the CDCPP and member States to discuss and agree on how the individual activities will be carried out.

In many cases, decisions on what to do or how to proceed will have to be taken by the CDCPP and/or its Bureau in the framework of specific items on its agenda. This document will provide a regularly updated overview of the various actions taken in order to meet the goals of the Terms of Reference.

Action required

The Bureau of the CDCPP is invited to examine the proposed work programme and calendar of meetings organised by the Council of Europe and give guidance to the Secretariat as to its implementation in the course of 2014-2015.

CDCPP work programme 2014-2015 based on its Terms of Reference

Terms of reference Under the authority of the Committee of Ministers, in the framework of the European Cultural Convention, the CDCPP will oversee the Council of Europe's intergovernmental work in the field of culture, heritage and landscape, and advise the Committee of Ministers on all guestions within its area of competence. Taking due account of relevant transversal perspectives, the overall aim is to share information on policy, exchange best practice and develop standards as appropriate relating to culture, heritage and landscape policies in States Party to the Cultural Convention and other relevant Conventions. The CDCPP advised the Committee of Ministers in the preparation of the following Recommendations: - Recommendation 2038(2014) "Europe's endangered heritage" At its meeting of 24-25 June 2014, the CDCPP Bureau, in response to a consultation of the Rapporteur Group on Education, Culture, Sport, Youth and Environment (GR-C), adopted the comments on behalf of the CDCPP on Recommendation 2038 (2014) on "Europe's endangered heritage" of the Parliamentary Assembly of the Council of Europe (Appendix 6 of Bureau Report - CDCPP-Bu(2014)10). The Secretariat of the CDCPP forwarded these comments to the Secretariat of the Committee of Ministers. The Committee of Ministers will be invited to decide on this issue in October 2014. - Recommendation 2049(2014) "Identities and diversity within intercultural societies". The Committee of Ministers' Deputies decided to send Parliamentary Assembly's Recommendation 2049 (2014) "Identities and diversity within intercultural societies" to the CDCPP for information and possible comments by 31 October 2014. A written consultation of the members of the CDCPP took place. The Secretariat of the CDCPP forwarded these comments to the Secretariat of the Committee of Ministers (cf. Appendix of Document CDCPP-Bu(2014)16). The Committee of Ministers will be invited to decide on this issue at a later stage. Current situation:

The implementation of the Faro Action Plan has focused on the Marseilles conclusions, in particular the setting up of a mechanism for reflection on the social and economic values of heritage for society (the Faro walks) combined with a testing and validating mechanism in the field (Faro Appreciations, Faro Applications and Faro Workshops). The main objective was to develop the operating methods for these different tools. A Faro Appreciation has been carried out in Pilzen (Czech Republic). Three more are planned in Viscri (Romania), La Louviere (Belgium) and Venice (Italy) in order to complete the terms of reference. Five Free Applications have been published on the Council of Europe's website. These missions and meetings of experts have already helped to consolidate Faro's reference framework. Since the launch of the Action Plan, Slovakia and Ukraine have ratified the Faro Convention, and Austria and Italy have signed it.

Current situation:

At its 3rd meeting (19-21 March 2014), the CDCPP took note of the best practices selected at national and European level for the Landscape Award of the European Landscape Convention, with a view to their wide dissemination in member States for their exemplary value and as a source of inspiration. It proposed to make also reference in the document to the Workshops on the implementation of the European Landscape Convention.

The following Council of Europe Meetings for the workshops on the implementation of the European Landscape Convention are organised in 2014-2015: - 11-12 June 2014, 14th Council of Europe Meeting of the Workshops for the implementation of the European Landscape Convention on "Forum of the national selections for the Council of Europe Landscape Award – Session 2012-2013", Wroclaw, Poland (study visit on 10 June 2014 for participants in the 3rd Session of the Award):

Current situation:

Holding of the 14th Workshop for the implementation of the European Landscape Convention on "Forum of the national selections for the Council of Europe Landscape Award – Session 2012-2013", in Wroclaw, Poland, on 10-12 June 2014 and launching of the 4th Session of the Landscape Award of the Council of Europe, the Parties to the Convention having been invited to present the applications to the Secretariat General of the Council of Europe by 10 December 2014.

According to Resolution CM/Res(2008)3 on the rules governing the Landscape Award of the Council of Europe, the Committee nominated Mr Phaedon Enotiades (Cyprus) as its representative who will be invited to take part in May 2015 in the International Jury of the 4^e Session of the Council of Europe Landscape Award of the European Landscape Convention.

d. European Heritage Days

Modalities

Joint Programme of the Council of Europe and European Union

Timeframe

2014-2015

Expected outcomes

Implementation of the third stage of development of the EHD Portal (www.europeanheritagedays.com) with the object of facilitating input of national events on the European Platform. This stage will involve the creation of direct import mechanisms for 7 of the 50 participating states (Austria, Belgium, France, Ireland, Norway, Slovenia, United Kingdom) and creation of two microsites (Armenia and Spain). This will result in more than 27 000 EHD events being uploaded to the EHD Portal by the end of 2014.

Implementation of a high level political "launch" of the EHDs activity in order to create visibility for the programme and stimulate broad public recognition of the on-going celebration of a "common European Heritage". This event is set to take place in the context of the Azerbaijani Chairmanship of the

Committee of Ministers on 14-16 October 2014.

Within the framework of the greater European cooperation, a set of cross-border activities will be developed aimed at encouraging and visibility including a photo competition.

To augment the role of the National Coordinators in the steering of the EHDs Programme. Exchange of information between members of the four working groups and independent meetings of these groups will take place.

European Heritage Days participation within an event in Italy, under the EU Italian Presidency.

Current situation

Four working groups of national coordinators were set up in Greece and will be fully engaged in the meeting in Azerbaijan.

4 out of 8 screenscraping mechanisms are implemented and over 3 000 events are currently visible on the website.

Current situation

The Working Programme of the European Landscape Convention refers to the preparation of pedagogical material for landscape education in primary and secondary schools (Implementation of Article 6 B - Specific measures – education) (CDCPP-Bu (2014)10, Appendix 5). The Meeting of the Working Group on landscape and education was held on 4-5 August 2014 (Report of the Meeting CEP-CDCPP (2014) COE/WG-EP 1). A draft recommendation is being prepared.

b. Draft Recommendation CM/Rec(2014)... of the Committee of Ministers to member States on intercultural cities

Modalities

At their 1189th meeting (22 January 2014), the Deputies decided to transmit the draft Recommendation of the Committee of Ministers to member States on intercultural integration (drawn up by the Steering Committee for Culture, Heritage and Landscape (CDCPP) to the European Committee for Social Cohesion, Human Dignity and Equality (CDDECS), to the European Committee on Democracy and Governance (CDDG) and to the Steering Committee for Human Rights (CDDH), for opinion before 31 May 2014.

Expected outcomes

Revised draft recommendation, for discussion by the GR-C and possible adoption by the CM.

Beneficiary(ies)

Current situation

At its meeting of 11 September, the GR-C decided to postpone this item, which will be examined soon.

Current situation

Two draft recommendations have been, or are being, drawn up by the Parliamentary Assembly (Committee on Culture, Science, Education and Media), with the support and participation of the Secretariat ("Europe's endangered heritage" and "Culture preservation in crisis and post-crisis situations"). Depending on the working group's expected results regarding the lessons learned from the technical cooperation projects [cf. document CDCPP-Bu(2014)14], some priority issues could emerge and be proposed by the CDCPP as subjects for draft Recommendations.

d. Other draft recommendations: use of new cultural policy tools and guidelines for evidence based policy making

Current situation

Initial work on policy orientations/guidelines on addressing the challenges posed by digitisation to the cultural sector is being carried out in the framework of the follow-up to the Baku Exchange Platform (4-5 July 2014). This work will provide input for subsequent work on a Council of Europe recommendation on new cultural policy tools and guidelines for evidence based policy making.

1.3 Preparation of the 8th Council of Europe Conference for the European Landscape Convention in 2015

Modalities

The aim of the Conference is to present to all member and observer States of the Council of Europe, and to international governmental and non-governmental institutions and organisations, the progress made in the implementation of the Convention, and practical questions related to its implementation. The Conference is the means by which the Council of Europe ensures, in accordance with Article 10 of the Convention, its implementation. The Committee of experts mentioned in Article 10 is, by virtue of a Committee of Ministers' decision, the CDCPP.

Timeframe

19-20 March 2015, Palais de l'Europe, Strasbourg

Expected outcomes

The conclusions of the Conference will be brought to the attention of the CDCPP which will then report to the Committee of Ministers.

Beneficiary(ies)

Members States of the Council of Europe and Parties to the European Landscape Convention

Current situation

The draft agenda and working documents for the Meeting are currently being prepared.

- 2. (ii) encourage European platforms and networks including electronic to collect best practice of, and exchange experiences on, policies and strategies on culture, heritage and landscape and their value for society, bearing in mind the key role of the intergovernmental dialogue
- 2.1. Member States are assisted in the development of democratic policies in the fields of culture through thematic policy reviews and the Compendium and Culture WatchEurope information systems

Modalities

Terms of Reference of the CDCPP.

Timeframe

2014-2015

Expected outcomes

- A targeted Cultural Policy Review of Serbia is available in 2015 with focus on three themes: (1) strategic orientations for culture, (2) modernising cultural infrastructure and (3) supporting culture and the creative sector.
- The Compendium on Cultural Policies and Trends in Europe/CultureWatchEurope offers comprehensive information including novel data and indicators on culture's contribution to democracy and the economic efficiency of financing culture.
- The Compendium serves as a European hub for the World-CP (global cultural policy information system, http://www.worldcp.org/) and offers methodological advice.

Beneficiary(ies)

Member States of the Council of Europe.

Current situation

The 2014 Compendium contract has been signed with the Council of Europe's operational project partner, ERICarts. The 2014 work focus will be on the creation of a new thematic space on culture and democracy. Preparations for the inclusion of country profiles from Belarus and Turkey are on the work agenda. Progress is made on the WORLD-CP, the Compendium's global extension, with new profiles for Chile and India and forthcoming profiles for Mongolia and Singapore (see also: http://www.worldcp.org/index.php).

An updated information and fund-raising letter was addressed to governments in August to seek voluntary contributions by member States so as to ensure the sophisticated functioning of the Compendium system.

The 2014 CultureWatchEurope conference, planned in conjunction with the Compendium Authors' meeting (Brussels, 4-5 December 2014, Belgian Presidency event) will serve for a review of initial results by forty cultural policy researchers and interested governmental representatives of the work on indicators on culture and democracy (see below under 4.1.).

Following a request made by the Minister of Culture in spring 2014, a Cultural Policy Review of Serbia could be carried out applying the novel methodology that foresees a small joint team of three national and three international experts who will produce one single review report.

2.2. Member States are assisted in the development of democratic policies in the fields heritage through thematic policy reviews and HEREIN information system

Expected outcomes

- The HEREIN Information System is developed into a knowledge base for the European Heritage Network.
- Heritage assessment and field action reports are published.
- Ad-hoc surveys provide background information on specific issues or useful material for identified indicators.

Beneficiary(ies)

Member States of the Council of Europe.

Current situation

21 countries have published and updated their national reports, and 14 others are in the process of doing so. The HEREIN system is therefore considered to be operational. Currently, 35 coordinators are activating the network. The Secretariat is continuing its efforts to work with 7 other countries that are inactive. The database has integrated a number of other reference documents and has developed by means of new features, in particular for targeted research on topics of common interest to the countries. The latest developments and the new HEREIN management procedures will be validated at the next Coordinators' meeting (Mons, Belgium, 18-20 November 2014). The priorities will then be to develop HEREIN into a knowledge base.

2.3. Member States are assisted in the development of democratic policies in the fields of landscape through thematic policy reviews and ELCIS information system Modalities The Recommendation CM/Rec(2013)4 of the Committee of Ministers to member States on the European Landscape Convention Information System of the Council of Europe and its glossary, recommends that States Parties to the Convention: - use the European Landscape Convention Information System of the Council of Europe with its glossary, in the framework of their co-operation as mentioned in the Convention: - co-operate to develop this Information System to fulfil these goals. **Timeframe** 2014-2015 **Expected outcomes** Continue to exchange information on all matters covered by the provisions of the Convention in order to promote knowledge of landscapes and landscape policies, in view of enhancing the quality of people's lives, taking care of their surroundings. Beneficiary(ies) Member States of the Council of Europe. **Current situation** The user manuals were prepared and a complementary work was done, in order notably to allow the use of the Information System in the two official languages of the Council of Europe. The member States of the Council of Europe will be invited to use the Information System at the end of 2014. A second phase will be launched in 2015 in order to allow the extraction and synthesis of data. Expected outcomes

- A novel indicator framework on the impact of cultural activity on democracy and the economic efficiency of financing culture is widely disseminated and a corresponding new narrative on Culture and Democracy launched;
- A platform for exchange on the impact of digitisation on culture for policymakers and cultural practitioners is set up and two guidelines for policy makers elaborated.

Current situation

Work on the indicator framework on culture and democracy started and a contract was prepared with the HERTIE School of Governance for the preparation of a draft framework that will be further elaborated with a consortium of leading European cultural research bodies in October.

Following a recommendation by the Bureau of the CDCPP in June, the draft framework will subsequently be presented to a larger review event linked to the 2014 gathering of Compendium Authors on 4-5 December in Brussels. First application tests shall be run in early 2015 in interested member states.

The 2013 Council of Europe Conference of Ministers of Culture requested the setting-up of an exchange platform for policy makers and cultural and media practitioners on the impact of digitisation on culture. The first platform meeting was held in the format of a multi-stakeholder conference on 4-5 July in Baku. The theme of the event was "Creating an enabling environment for digital culture and for empowering citizens" and it brought together some 100 participants. Work concentrated on gathering orientations for moving from pre-digital to digital cultural institutions and on emerging trends of cultural production and related needs of the cultural sector. Elements for future policy guidelines have been drawn from the debates; the dedicated CDCPP work group, together with the Secretariat, will follow-up these elements in view of finalising policy guidelines in 2015. A second platform meeting – launching the policy guidelines and carrying the work process on culture and digitisation further – may be organised in 2015, pending support by interested member States.

Other activities

In the framework of the 60th anniversary of the European Cultural Convention a Council of Europe brochure and exhibition "Culture: Heart and Soul of Democracy" has been produced. A number of events are being organised to mark the anniversary and feature the exhibition.

The 30th Council of Europe Art Exhibition "Desire for Freedom. Art in Europe since 1945" generated several small exhibitions and workshops on the theme. The German Historical Museum in Berlin organised a symposium on "The European idea in art and art history" on 25-26 September 2014. A closing international conference is planned in Milan in March 2015.

The JP Roma Academic Network (RAN) will hold six workshops in the period June-November 2014 including on issues of Roma integration and evidence-based policy making, social vulnerability, history and policy in Romani Studies, housing policies, criminal justice and policing matters and health issues. A meeting of its Scientific Committee will take place on 7 November in Paris .The SC will review the project action plan 2014-15 and potential for future development of the network after the conclusion of its 2nd phase in May 2015, including in view of the RAN's contribution to the work of the Special Representative of the Secretary General of the Council of Europe on Roma issues. This is relevant to ensure research input to the creation and running of a European Institute on Roma, as envisaged by the Council of Europe and partners.

	Current situation The first meeting of the CPP-CINE took place on 3-4 April in Paris to prepare and implement the revision of the European Convention on Cinematographic Co-production along the needs identified through an independent evaluation of the Eurimages Fund (Olsberg SPI, November 2013) and in line with decisions taken in 2013/14 by the CDCPP and GR-C. It brought together 15 national experts. They held an exchange on the legal aspects and the various options for the Convention revision) and after agreeing on their working methodology, revised articles 6 (Proportions of contributions from each co-producer); 7 (Rights of co-producers) and Appendices I (Application procedure) and II (Point system). The second meeting of the CPP-CINE took place in Paris on 29-30 September 2014 and fine-tuned revision works. On the basis of the achievements, the CPP-CINE and the Secretariat will prepare the 2015 intergovernmental meeting on the Convention revision (Strasbourg, 12-13 February 2015).

The Deputies instructed the steering and ad hoc committees to carry out, at regular intervals, within the limits of the available resources and bearing in mind the priorities of each committee, an examination of some or all of the conventions for which they have been given responsibility, in co-operation, where appropriate, with the relevant convention-based bodies, in order to:

- propose ways of improving the visibility, impact and efficiency of some or all of the conventions for which they have been given responsibility;
- draw the attention of member States to the relevant conventions:
- where necessary, identify any operational problems or obstacles to ratification of the relevant conventions, and draw the attention of member States to reservations which impact substantively on the effectiveness of their implementation;
- encourage States to regularly examine the possibility and/or desirability of becoming a Party to new Council of Europe conventions;
- assess the necessity or advisability of drafting amendments or additional protocols to the conventions for which they have been given responsibility or drafting supplementary conventions;
- and to report back to the Committee of Ministers;
