

**Communication by Tetiana Farmahei, Ukraine delegate to the CDMSI, on recent developments  
18 April 2016**

On behalf of the official representative of Ukraine in the CDMSI the National Council of Television and Radio Broadcasting of Ukraine would like to inform you the following.

Upon the results of taking by the Committee of Ministers and the Parliamentary Assembly of the Council of Europe of the recommendation acts related to the media area and information society have been sent to the appropriate Ukrainian governmental authorities responsible for their consideration and usage within implementation of the policy related to the issues in such areas, as: information society development, protecting and promoting the right to freedom of expression and the right to private life with regard to network neutrality, increasing transparency of media ownership, media responsibility and ethics, protection of whistle-blowers, co-operation against cyberterrorism and other largescale attacks on the Internet.

The relevant governmental authorities, in particular, the Ministry of Justice of Ukraine, the Ukrainian Parliament Commissioner for Human Rights, the Ministry of Information Policy of Ukraine have decided to use the acts in their current activities in order to approximate the national framework in line with the standards developed by the Council of Europe.

Also the above recommendation acts have been placed on the websites of these stakeholders in order to support their further public dissemination in Ukraine.
