Dear Director,

I am pleased to share with you my evaluation of the state of relations and co-operation between the Office for Democratic Institutions and Human Rights of the Organization for Security and Co-operation in Europe (hereinafter "ODIHR") and the Council of Europe (hereinafter "CoE").

Since the participating States of the OSCE and the member states of the CoE adopted the Declaration on Co-operation between the two organizations ten years ago¹, the relations and co-operation between ODIHR and the CoE have developed substantially.

The following examples could also be referred to confirming the continuing relevance of the 2004 – 2005 documents still today:

- the Director of ODIHR is the OSCE focal point for one of the four priority areas dealt with by the CoE-OSCE Co-ordination Group "promoting tolerance and non-discrimination";
- in electoral matters, ODIHR and the CoE Parliamentary Assembly are the most important partners in the observation of elections, whilst the joint opinions on electoral legislations by ODIHR and the CoE Venice Commission are respected as benchmarks in Europe;
- ODIHR and the CoE Venice Commission also have a long standing cooperation on joint opinions in the human dimension other than elections, including joint Guidelines on Freedom of Religion or Belief, Freedom of Assembly, Political Party Regulation or Freedom of Association;
- ODIHR continues to act as the OSCE liaison to the Council of Europe on local governance in South Eastern Europe and as such facilitates annual meetings between OSCE Field Operations and CoE Field Offices;

The adoption of this Declaration was announced by a Joint Statement signed by the Chairman-in-Office of the OSCE and the Chairman of the Committee of Ministers on 17 May 2005 in Warsaw - hereinafter the "2004-2005 documents").

- ODIHR was granted participant status in 14 CoE Steering Committees or their subordinate bodies and an observer status in four committees established under the CoE conventions;
- the CoE contributes to each item on the agenda of the annual OSCE Human Dimension Implementation Meetings and actively participates in other OSCE Human Dimension events;
- intercultural dialogue and education for democratic citizenship, human rights and mutual respect and understanding, counter-terrorism and human rights, freedom of religion or belief, strengthening the rule of law, democratic governance and combating corruption, women's and youth political participation, hate crime, intolerance and discrimination against Roma and Sinti are other fields where ODIHR and the CoE have established and continue to develop close cooperation;
- the importance of the ODIHR-CoE relations was underlined by the opening in 2011 of the CoE Office in Warsaw in charge, in particular, of relations with ODIHR.

With reference to our recent exchanges of views about possible modalities for further strengthening the interaction and co-operation between ODIHR and the CoE within the existing framework of implementation of the 2004-2005 documents, I am pleased to confirm that:

- the First Deputy Director of ODIHR and the Director of External Relations of the CoE Secretariat will act as respective contact points for co-ordination and further strengthening the interaction and co-operation between ODIHR and the CoE. The CoE Office in Warsaw will facilitate the communication between the contact points.
- the contact points will meet at least once per year, preferably on the occasion of the meeting of the Co-ordination Group (in Strasbourg) or a Human Dimension Meeting (in Warsaw).
- in addition to the continuation and further development of the existing ways of interaction, the feasibility of the following modalities will be jointly looked into:
 - enhanced political dialogue, including exchanges of views between the ODIHR Director and the CoE Committee of Ministers and addresses by the CoE Secretary General or other Senior Officials to the OSCE Human Dimension meetings;
 - co-ordination of future activities as from the early stages of the planning processes.

I am looking forward to our future co-operation.
