

**Comments from Bosnia and Herzegovina to the Comparative Study on filtering, blocking and take-down of Internet content
(22/03/2016)**

The Ministry of Security of Bosnia and Herzegovina has received from the Ministry of Foreign Affairs of Bosnia and Herzegovina a part of Comparative study on blocking, filtering and take-down of illegal Internet content, produced by the Swiss Institute of Comparative Law, that is relevant to Bosnia and Herzegovina.
