Context

The seminar is organised by the Congress of Local and Regional Authorities of the Council of Europe (the Congress) within the thematic programme “Strengthening institutional frameworks for local governance”, implemented jointly with the Council of Europe Centre of Expertise for Local Government Reform, Directorate General of Democracy. This programme is funded by the European Union and the Council of Europe, and implemented by the Council of Europe, through the Programmatic Co-operation Framework for 2015-2017 for Armenia, Azerbaijan, Georgia, Moldova, Ukraine and Belarus.

The aim of the seminar is to increase the awareness and readiness of mayors to implement higher ethical standards in public policies, and to promote ethical governance and transparency in their daily activities. It will provide a platform for local elected representatives from the region to share experience between themselves and with peers from other European countries on the ways to develop ethical policies in local decision-making. Presentations and working groups will focus on public ethics and its role in building trust in local authorities, taking into consideration the available tools and mechanisms to enhance transparency and accountability at the local level. The seminar will also serve as a means for discussions on the local initiatives to be implemented in the region.

Interpretation will be provided in English, Russian and Ukrainian, with working groups in English and Russian only.
