MEETING REPORT

Item 1: **Opening of the meeting and adoption of the agenda**

1. Drafting Group F on the reform of the Court (GT-GDR-F) held its 5th meeting in Strasbourg from 18 to 20 February 2015 with Mr Martin KUIJER (The Netherlands) in the chair. The list of participants appears at Appendix I. The agenda, as adopted, appears at Appendix II.

2. The Group started the examination of the preliminary consolidated draft CDDH final report.

3. The Group took note of the holding of the High-Level Conference on “*the implementation of the European Convention on Human Rights, our shared responsibility*” (Brussels, 26-27 March 2015), organised in the framework of Belgium’s chairmanship of the Committee of Ministers. The elements resulting from the Brussels Conference will be taken into account in the revised version of the consolidated draft report with a view to the 6th meeting of the Group.

4. Concerning the organisation of its future work, the Group agreed on the following:

- Experts are invited to submit their comments and/or proposals to the Secretariat (irene.kitsou-milonas@coe.int; haldia.mokeddem@coe.int) on the preliminary consolidated draft report (GT-GDR-F(2015)005) by **Friday 6th March**;
- The Secretariat will prepare a revised version of the report on the basis of the discussions held at the present meeting as well as of the comments and proposals submitted by the experts (by 6th March);
- The revised preliminary consolidated draft report will be sent out on **2nd April**;
- Experts are then invited to submit written contributions on the revised text by **Monday 13th April**, for distribution before the 6th meeting.

5. The 6th meeting will be held on 15-17 April 2015.
