MEETING REPORT

1. Drafting Group F on the reform of the Court (GT-GDR-F) held its 6th meeting in Strasbourg from 15 to 17 April 2015 with Mr Martin KUIJER (The Netherlands) in the chair. The list of participants appears at <u>Appendix I</u>. The agenda, as adopted, appears at <u>Appendix II</u>. On behalf of the Director General, Mr Mikhail LOBOV, Head of the Human Rights Policy and Co-operation Department, stressed the importance of the current Group's work in the present context of the Organisation.

Item 2: Information on the High-Level Conference on "the implementation of the European Convention on Human Rights, our shared responsibility" (Brussels, 26-27 March 2015)

2. Ms Isabelle NIEDLISPACHER (Belgium), Vice-Chair of the Group, presented the results of the Brussels High-Level Conference. The Group took note of the Brussels Declaration and agreed to a *verbatim* presentation of its relevant parts in the draft CDDH final report.

Item 3: Revised consolidated draft CDDH final report

3. The Group examined the revised consolidated draft CDDH final report (doc. GT-GDR-F(2015)006).

4. In the light of the proposals put forward during the meeting, a revised version of the text will be transmitted to the Committee of Experts on the Reform of the Court (DH-GDR) in view of its 8th meeting (27-29 May 2015) (see also item 4), except for sub Section D (the ECHR mechanism in the European and international legal order). Concerning the latter, the Group decided to discuss it in depth at its 7th meeting in September. To this end, it invited the DH-GDR to give guidance on how to address the specific issue of the EU accession to the Convention. The Group also decided to undertake a more detailed examination of certain other issues at its 7th meeting, such as the affording of just satisfaction to applicants under Article 41 of the Convention.

Item 4: Organisation of future work and other business

5. Concerning the organisation of its future work, the Group agreed on the following:

- Experts are invited to submit their comments to the Secretariat (<u>DGI-CDDH-Reform@coe.int</u>) on the revised consolidated draft CDDH final report (GT-GDR-F(2015)006) by <u>Friday 24th April</u>;

- The Secretariat will prepare a revised version of the text on the basis of the discussions held at the present meeting as well as of the comments submitted by the experts;

- The revised text will be sent out on **Friday 15th May**;

- Experts are then invited to submit written contributions on the revised text by **Thursday 21^{st} May**, for transmission to the DH-GDR.

6. The 7th meeting will be held on <u>**Tuesday 8 - Thursday 10 September 2015**</u> (instead of 2-4 September 2015, as initially scheduled).

7. The Group took note of the holding of a Conference on <u>"Parliaments and the European Court of Human Rights"</u>, co-organised by the Middlesex University and the Helsinki Foundation for Human Rights, in Warsaw on 12 May 2015. It also took note of the publication of <u>"Parliaments and Human Rights – Redressing the democratic deficit"</u>, edited by Murray Hunt, Hayley Hooper and Paul Yowell (Hart Publishing, First edition, March 2015).
