CONSULTATIVE COMMITTEE OF THE CONVENTION FOR THE PROTECTION OF INDIVIDUALS WITH REGARD TO AUTOMATIC PROCESSING OF PERSONAL DATA [ETS 108] (T-PD)

16th meeting of the Bureau

Paris, 17-18 December 2009

ABRIDGED REPORT

- 1. The Bureau of the T-PD held its 16th meeting at the Council of Europe's office in Paris, on 17-18 December 2008. The list of participants and agenda of the meeting are respectively set out in Appendices I and II of this report.
- 2. The Secretariat informed the Bureau about new developments since its last meeting in October 2008: The budget of the Council of Europe for 2009 had been adopted by the Committee of Ministers on 25 November 2008. As in several sectors, the data protection budget registered a cut of more than 10%, which did however not affect meetings: as was the case this year, the budget of the T-PD foresaw one plenary meeting and 3 Bureau meetings for next year, all of them with a duration of 2 days each.
- 3. As regards new developments in the field of data protection, Convention 108 did not register any new signature or ratification. Therefore, this Convention still had 40 ratifications and 4 signatures non followed by ratifications. The Additional Protocol to Convention 108 regarding supervisory authorities and transborder data flows had been ratified by Serbia on 8 December 2008 and signed by Estonia on 15 December 2008. As a result, the Additional Protocol had been ratified by 22 states and signed by a further 15. The Amendments to Convention 108 allowing the European Communities to accede had been accepted by Georgia on 12 November 2008. Therefore, there were currently 29 States out of the 40 State parties to the Convention that had accepted them.
- 4. The Secretariat also informed the Bureau about two recent decisions of the European Court of Human Rights that concerned data protection issues, in the cases of S. and Marper vs UK and K.U vs Finland. Moreover, the Council of Europe Human Rights Commissioner, Thomas Hammarberg, had published an issue paper on "protecting the right to privacy in the fight against terrorism".
- 5. The Bureau of the T-PD had an exchange of views on the future of standard setting in the field of data protection and in particular the relations with the European Committee on Legal Co-operation (CDCJ), which terms of reference include data protection. The Secretariat and the Chair reported on the discussion that took place on this issue at the last Bureau meeting of the CDCJ (see document CDCJ-BU (2008) 25). The Bureau of the T-PD:

- agreed to send, after its next meeting, the draft recommendation on profiling and its explanatory memorandum to the CDCJ for preliminary consultation in writing. It would then take into account comments received in its further work on the text:
- agreed that the draft recommendation and explanatory memorandum, once adopted by the T-PD, would be sent on to the CDCJ with a view to its approval and further transmission to the Committee of Ministers for adoption;
- expressed its wish that this process could be accomplished speedily, in order for the recommendation to be adopted by the Committee of Ministers as soon as possible;
- took note of the invitation of the CDCJ to present suggestions for new standards in the area of data protection;
- took note of the suggestion of the CDCJ to consider including it and other relevant steering committees such as the the Steering Committee on Mass Media (CDMC), the Steering Committee on Human Rights (CDDH) and the Steering Committee on Criminal Problems (CDPC) as participants in its Plenary meetings;
- 6. The Bureau of the T-PD completed the first reading of the draft recommendation on the protection of personal data in the framework of profiling and started the second reading. It agreed to continue this work at its next meeting.
