17th meeting of the Bureau

Strasbourg, 9 and 10 February 2009

DRAFT ABRIDGED REPORT

- 1. The Bureau of the T-PD held its 17th meeting at the Council of Europe in Strasbourg on 9 and 10 February 2009. The list of participants and agenda of the meeting are reproduced in Appendices I and II respectively of this report.
- 2. The Bureau took note of the information provided by the Secretariat on developments since its December 2008 meeting. Convention 108 had been ratified by Monaco on 24 December 2008, bringing the total number of ratifications to 41 and the number of signatures not followed by ratification to 3. The Additional Protocol to Convention 108 regarding supervisory authorities and transborder data flows had also been ratified by Monaco on 24 December 2008. It now had 23 ratifications and 13 signatures. The Amendments to Convention 108 authorising accession by the European Communities had been accepted by Monaco on 29 January 2009. Accordingly, there were currently 31 out of the 41 states parties that had accepted the amendments to the Convention.
- 3. The Secretariat also provided information on the third Data Protection Day held on 28 January 2009. It had been very successful this year, with events being organised in over 30 member states and in Canada, the United States and Mexico, and by the European Union institutions. The Secretary General's representative in Brussels, Ambassador Torbjørn Frøysnes, along with Commissioner Jacques Barrot and Peter Hustinx, the European data protection supervisor, had attended the prize-giving ceremony organised by Euroschoolnet and Microsoft for the winning videos produced by young people on the subject "Surf the net think privacy". The Secretary of the T-PD had attended a conference organised for Data Protection Day in Albania, during which the deputy Prime Minister and the Minister of Justice had stressed the importance of reform in the data protection field in Albania, and the success of the Council of Europe project.

- 4. The Bureau of the T-PD continued with the second reading of the draft recommendation on the protection of personal data in the context of profiling. It held an exchange of views on the scope of the recommendation and agreed to consult the T-PD on this point through written procedure.
- 5. The draft as it resulted from the discussions at the meeting would be forwarded to the T-PD and the CDCJ for consultation, with comments to be received by 15 April 2009. Any such comments would be examined at the next Bureau meeting, to be held on 18 and 19 May 2009, in place of the plenary meeting initially scheduled. The plenary meeting would be held on 3 and 4 September 2009.
