ABRIDGED REPORT

Directorate General of Human Rights and Rule of Law

The Bureau of the Consultative Committee of the Convention for the Protection of Individuals with regard to Automatic Processing of Personal Data (T-PD-BUR) held its 37th meeting in Strasbourg from 9 to 11 December 2015, with Mr Jean-Philippe Walter (Switzerland) in the chair. The agenda, as adopted by the T-PD Bureau and the list of participants are set out in Appendices I and II.

The Bureau of the T-PD:

- 1. took note of the information provided by Mr Jan Kleijssen, Director of the Information Society and Action against Crime Directorate, in particular on:
 - the importance for the T-PD to be involved in the discussion on surveillance and terrorism, boosted by the Paris terrorist attacks, in order to strike the right balance between a securitarian approach and applicable human rights, including the right to respect for privacy and the protection of personal data;
 - the Ministers' Deputies decision to invite Tunisia to accede to Convention 108 and to its Additional Protocol;
 - the modernisation of Convention 108, linked in particular to the state of progress of the trilogue negotiations within the EU that is about to be concluded and which should enable the Committee of Ministers' Rapporteur Group on Legal Co-operation to resume discussions at its next meeting in 2016 and decide on the subsequent steps;
 - the launching of a series of "Data Protection Talks" with the participation of Max Schrems for the first edition to be held after the 37th Bureau meeting on 11 December, to discuss the ruling of the Court of Justice of the European Union of 6 October 2015;
- 2. took note of the concerns expressed once again by the Chair on the inadequacy of the **resources** allocated to the Committee and its Secretariat in relation to the importance and relevance of the topic, as well as the budgetary needs that will arise when establishing the follow-up mechanism, which will require not only additional staff for the Secretariat but also a second annual Plenary meeting. The Data Protection Commissioner raised similar concerns highlighting that additional staff is essential for the accomplishment of her duties;
- 3. took note of the information presented by the experts, Mr Gert Vermeulen and Mr Dariusz Kloza, on the issue of **Cooperation between Data Protection Authorities** within the framework of the Global Cross Border Enforcement Cooperation Arrangement adopted at the 36th International Conference of Data Protection and Privacy Commissioners with regard to the current provisions of the Convention and draft modernised Convention 108. It held an exchange of views with the experts and instructed the Secretariat to draft a letter to the International Conference addressing the relevant provisions of Convention 108 and their articulation with the Arrangement;
- 4. examined the **draft Recommendation on the protection of health data** presented by the expert, Ms Jeanne Bossi Malafosse, and agreed that the Secretariat and the expert will revise the draft recommendation on the basis of the discussions and comments received in writing, for its transmission to delegations and observers for comments before the 38th Bureau meeting;
- 5. took note of the information presented by Mr Philip Kerfs, on the OECD Standard for **Automatic Exchange** of Financial Account Information, in particular regarding Appendix C to the Multilateral Agreement between the competent authorities, and invited Mr Kerfs to keep the Bureau informed on any further developments in this regard;
- 6. examined the draft guidelines on "the protection of individuals with regard to the processing of personal data in a world of **Big Data**", prepared by the Secretariat on the basis of the experts' report and instructed the Secretariat to forward a revised version to the delegations and observers for written comments, in view of the 38th Bureau meeting;
- 7. took note of the information provided by representatives of other Council of Europe Bodies:
 - the Secretariat of the Cybercrime Committee (**T-CY**), on the decisions taken during the T-CY 14th Plenary meeting (1-2 December 2015) which are of interest for the T-PD, and in particular on the

- intention of the Cloud Evidence Group to organise a meeting on 23 May 2016 to continue the dialogue with data protection experts and to report back to the T-CY on the outcomes;
- the Secretariat of the Committee of Experts on Terrorism (CODEXTER), regarding the participation of the T-PD in the drafting group that will update Recommendation Rec(2005)10 on the use of "special investigation techniques" in relation to serious crimes including acts of terrorism and appointed Mr Péter Kimpiàn (Hungary) to represent the T-PD in the drafting group;
- the Secretariat of the Bioethics Committee (DH-Bio), concerning notably the approval by the DH-Bio of the draft recommendation "on research on biological materials of human origin" and the finalisation of the draft recommendation on "the processing for insurance purposes of personal health-related data, in particular data resulting from genetic tests", as well as concerning future areas of possible cooperation (draft Recommendation on the protection of health data and work on emerging technologies);
- 8. took note of the information presented by Mr Péter Kimpiàn on his participation in the 54th **ICANN** meeting in Dublin, stressing the importance of T-PD participation in ICANN's forthcoming meetings;
- 9. took note of the information presented by the expert, Marie Georges, concerning her report on "Passenger Name Records", and after holding a discussion with the expert, examined the "draft opinion on Air Transport Passengers Information" prepared by the Secretariat, instructing it to submit a revised version to delegations and observers for written comments before the 38th Bureau meeting;
- 10. took note of the information provided by the Data Protection Commissioner on the **revision of the** "**Regulation of 1989** instituting a system of data protection for personal data files at the Council of Europe", highlighting the importance of being consulted on the draft Regulation, and agreed with the request of the Chair regarding the consultation of the T-PD in order to examine the consistency of the draft Regulation with Convention 108 and the necessity to adopt quickly the revised Regulation;
- 11. took note of the information presented by the **observers**, by AEDH on the organisation of a Conference on 27 January 2016 to celebrate the 10th anniversary of the Data Protection Day, by ICRC on the adoption in June 2015 of the rules on personal data in the humanitarian work field, the adoption of the resolution on "Privacy and International Humanitarian Action" at the 37th International Conference of Data Protection and Privacy Commissioners, as well as the cooperation with the Brussels Privacy Hub that will enable the organisation of six workshops which aim at issuing guidelines on personal data protection for humanitarian actions and the cooperation with the EDPS which will enable the organisation of a workshop on data protection within International Organisations on 5 February 2016 in Geneva;
- 12. confirmed that the **38th Bureau meeting** will be held in Paris from 22 to 24 March 2016 and the **33rd Plenary** meeting will be held in Strasbourg from 29 June to 1 July 2016.
