TRAVEL TO/FROM Skopje

Travel expenses for international participants between the place of residence and the place of the meeting of the representatives per participating country will be borne by the Council of Europe in accordance with the Council of Europe rules. **The Council of Europe Secretariat will arrange prepaid electronic tickets.**

Those participants who prefer to arrange their travel on their own are kindly requested to do so in the most economical manner. Practicalities:

- Their travel expenses will only be reimbursed by a bank transfer after the Conference and upon presentation of documentary evidence of the sum actually paid (invoice, copy of credit card slip, etc.).
- If an invoice is provided, this must be the original document issued by the travel agency or airline that issued the ticket.
- If an electronic ticket is purchased, **a confirmation** of the online booking giving the total cost of the ticket must be provided, along with proof of payment (invoice, credit card slip, monthly or internet bank statement). This evidence of the expenditure together with the relevant travel tickets (plane, train, etc.) should be attached to the completed claim form for reimbursement.

All these documents should be returned to the Secretariat at the latest at the end of the meeting.

If no public transport is used, travel expenses will be reimbursed according to Article 6 of the Rules.

The travel to/from Skopje airport to the hotel will be borne by each participant.
