Protecting children affected by the refugee crisis from sexual exploitation and sexual abuse

DATA (Lanzarote Convention, Chapter III)

- 1) How many migrant and asylum-seeking children (accompanied and unaccompanied)¹ are in your country as a result of the refugee crisis?
 - a) Please provide estimates, if exact data is not available, for the period between 1 July 2015 and 30 June 2016,² and specify how many of these children are victims or presumed victims of sexual exploitation and sexual abuse;
 - b) Describe how the victims of sexual exploitation and sexual abuse were identified or describe the challenges faced to identify them. Specify whether a distinction is made between victims of sexual exploitation/abuse prior to the entry on your territory (Group 1) and after entry (Group 2) and provide data/estimates of the two groups of victims. Please also explain how the age is determined in case of doubt;
 - Indicate also how the data collected is used to offer a coordinated response between the different agencies in charge of the protection from, the prevention of and the fight against sexual exploitation and sexual abuse of children;
 - d) Identify the institution(s) responsible for the collection of above data.

According to the official reports from the state and entity's agencies there was no crossing of bigger groups of migrants from Syria, Afghanistan and other countries to the territory of Bosnia and Herzegovina.

- 2) What are the specific measures taken to prevent that children affected by the refugee crisis fall victims of sexual exploitation and sexual abuse?

As far as our legislation stipulates, all the children who are in the our territory have the right to same protection and treatment regardless their citizenship.

COOPERATION (Lanzarote Convention, Chapter IX)

- 4) Provide examples of successful cooperation with other Parties to the Lanzarote Convention for the purpose of:
 - a) Preventing and combating sexual exploitation and sexual abuse of children affected by the refugee crisis;
 - b) Protecting and providing assistance to victims;
 - c) Investigations or proceedings concerning the offences established in accordance with the Lanzarote Convention.

The Council of Ministers of the BiH adopted the Information on evaluation of capabilities of Bosnia and Hercegovina in light of the refugee crisis in the region and the EU. The Information was adopted on 8 September 2015. All institutions and agencies have been obliged to implement the measures defined by the Plan of urgent measures for provision of additional capacities, control and management for potential migration through the territory of BiH. The Ministry of Security and Coordination body for migrations have been obliged to cooperate with other relevant instruction regarding implementation of the Plan of urgent measures, to regularly update it and report to the Council of Ministers of BiH.

"The Plan of urgent measures ensure human treatment of the refugees and migrants in accordance to the legislation that treat migrations and asylum and in accordance to the international legislation providing, at the same time, for the maximum security in given circumstances"/

The State institutions that deal with the issues of migrations are: Ministry of Security, Ministry of Foreign Affairs and Coordination body for migration issues.

In additional to the above mentioned state level institutions, the Federal Ministry of Interior, the RS Ministry of Interior, cantonal ministries of interior, and the Brcko District Police are authorized to support the Department for dealing with foreign citizens and provide information relevant for migrations, such as reporting the foreign citizens staying in the country or support extraditions if required.

5) Please provide any other additional information which may be useful to identify areas for targeted cooperation aimed at ensuring that children affected by the refugee crisis are effectively protected from sexual exploitation and sexual abuse and in guaranteeing their human dignity and physical and psychological integrity.
