 - February - april : consultation of the NGOs
 - Autumn : second consultation of the authorities
- End of 2015 : publication

→ Response of the swiss Confederation and cantons NE and JU to the 14 points of the recommandation No 169 (Bern Convention)



Main Objectives




100 Hydrological Regime

101: New «*Water Reglement*» regulating three hydroelectric plants

- Hydropeaking
- Residuel waters between the plants
- Monitoring (temperature, discharge, stranding, spawning of trout and grayling, electric fishing)

102: Additional measures

- Necessity of further adaptations



200 Physico-chemical Water Quality (4)

201: Improvements of different sewage treatment plants in NE and JU

- Technical adaptations of different wastewater treatment plants
- Equipment for a micropollutant treatment stage

202: Improvements of the connecting systems of wastewater in NE and JU

- Planification plan and connecting systems

203: Assessment of the flux of pollutants in the River Doubs

- Modelling
- Identifying priorities

204: Permanent survey of the water quality

- Continuous analysis of water quality (pH, temperature, conductivity, turbidity, N, oxygen) in Ocourt



300 Ecomorphology, Connectivity of the aquatic Habitats (5)

301: Enough space for the river

→ Setting up of a specific group to determine the necessary space (2016)

302: Restoration of 5 tributaries of the Doubs

→ Restoration of 5 tributaries realized in 2015

→ Restoration of an additional tributary in 2016

303-304-305: Restoration of the fish migration at three obstacles

→ Moulin Grillon: analysis of variants, realisation planned in 2017

→ Bellefontaine and Ocourt: priority identified, solution still to be found (end of 2016)



400 Natural Habitats, Connectivity and Species (3)

401: Emerald management plan «*Clos du Doubs*»

- Setting up of a specific structure by canton of JU
- Working group: principles of the management plan

402: Management plan for three alluvial zones of national importance

- Alluvial zone «*La Lomenne*»: validation of management plan 2016, implementation in 2017
- Alluvial zones «*Clairbief*» and «*La Réchesse*»: validation of the management plan 2017, implementation in 2018

403: Base for the implementation of an ecological infrastructure

- Launching of a pilot-project for the period 2016-2020



500 Research and Monitoring (3)

501: Monitoring of the apron

→ Continuation of the program launched in 2000

502: Genetical analysis of the apron

→ Investigations done

→ Genetic specificity of the Doubs population

503: eDNA apron

→ Analysis of feasibility



600 Communication (5)

601: Setting up of an advising board involving the NGO and Parc

- First session: March, 24th 2016
- Second session: November, 24th 2016

602: Documentation about the apron

- DVD and CD available (public, school, exhibition,)

603: Communication and sensibilisation by the local population

- Flyer on the «Réserve cantonale du Doubs» (2016)
- Program and measures to be defined (2017) by the Parc

604: Preventive measures to assure good health of the aquatic fauna
